Narrative:

Evidence collected from J. Talbott ISP 3431, interviews with neighbors:

On November 14, 2022, I went to 1122 Kind Rd., with Sgt. Blaker, to observe the scene. I walked through the house and around the outside of the residence, along with other investigators, looking for possible evidence. ISP investigators were on scene, walking through for a second time, looking for additional evidence. I walked around the south side of 1122 King Rd. up the hill and along the fence line for [REDACTED] Walenta. The backyard for [REDACTED] Walenta backs up to the back yard area of 1122 King Rd. I spoke with S [REDACTED] G [REDACTED], at [REDACTED] Walenta, and asked for his permission to look through his backyard area, which he said I could. G [REDACTED] told me he was a person who previously called dispatch to provide information about what he observed. I told G [REDACTED] after looking over the area and through the residence on King Rd. I would come back and get a statement from him. I did not locate anything of interest in the backyard of [REDACTED] Walenta or on the hillside behind 1122 King Rd. I walked into 1122 King Rd. and looked through the house with other investigators.

The following 4 evidence items were collected by ISP 3431 J. Talbott inside 1122 King Rd. on November 14, 2022 and turned over to me on scene. ISP took photos of the items in the places they were collected from. I booked the following items into MPD evidence. A copy of the evidence property receipt, relating to these items, is attached electronically to the case file:

Exhibit 57: Rolled \$2.00 bill, located on the desk in F2 BDR1 northwest.

Exhibit 58: Blue powder (suspected drugs), located on the desk in F2 BDR1 northwest.

Exhibit 59: Blood sample west wall F2 living room.

Exhibit 60: Blood sample F3 BDR2 NW wall.

I spoke with the following people who live at [REDACTED] Walenta. My conversations with the S [REDACTED] G [REDACTED], M [REDACTED] M [REDACTED], and T [REDACTED] M [REDACTED] were recorded and are attached electronically to the case file.

S [REDACTED] G [REDACTED] told me the following: He woke up a couple of times Saturday night. He looked at the clock, saw it was 0417 hours, and said after about 5 minutes of waking up he heard a dog barking, outside, from the direction of 1122 King Rd. G [REDACTED] said he was going in and out of sleep and after an hour, around 0500 hours, he still heard the dog barking outside from the direction of 1122 King Rd. G [REDACTED] said his bedroom is on the far north east side of [REDACTED] Walenta and is closest to the backyard of 1122 King Rd. G [REDACTED] said there is a motion light outside of his window and said if it turned on he would have noticed it. G [REDACTED] told me he has lived in this residence since January and has not heard the dog barking outside before in the middle of the night.

I next spoke with M [REDACTED] M [REDACTED]. M [REDACTED] told me on the 13th he woke up around 0230 hours and left the house around 0300 hours. M [REDACTED] said he had an [REDACTED] extended training day and it lasted about 12 hours. M [REDACTED] said he finished his extended training day around 1800 hours, at Buffalo wild wings, and arrived home around 1830 hours. M [REDACTED] said he was with approximately 20 [REDACTED] members and did not notice anyone, who should have been there, was not there. M [REDACTED] did not remember hearing anything in particular when he woke up or left around 0230 and 0300 hours. M [REDACTED] did not hear the dog barking.

I next spoke with T [REDACTED] M [REDACTED]. T [REDACTED] told me he did not hear a dog barking at any point. T [REDACTED] said he had been out at the bars the evening of the 12th and got home around 0230 hours. T [REDACTED] said he sleeps with ear plugs in. T [REDACTED] said his sister, M [REDACTED] M [REDACTED] mentioned she saw Madison Mogen at some point at the Corner Club. T [REDACTED] provided me with his sisters phone number.
