Summary Narrative

On November 15, 2022, Idaho State Police (ISP) Detective (Det.) Hugh Powell and I, ISP Det. Jacob Schwecke conducted an interview with [REDACTED] [REDACTED] ([REDACTED]) at the Moscow Police Department, located at 155 Southview in the city of Moscow, Latah County, Idaho. [REDACTED] is a potential witness in a homicide case.

Narrative

1. On November 15, 2022, ISP Det. Hugh Powell and I conducted an interview with [REDACTED] at the Moscow Police Department, located at 155 Southview in the city of Moscow, Latah County, Idaho. Reference the video/audio interview recording for full details. [REDACTED] provided the following information:

A. He left his apartment at approximately 8:00 p.m. on November 12, 2022, with a female friend named [REDACTED]. They went to Mingles, a bar in Moscow, ended up meeting another female friend there, and the three of them left for Corner Club between approximately midnight and 1:00 a.m.

B. At the Corner Club he really noticed a girl who "couldn't stand", was touching everyone, and he stated, "I thought she was on something. So I was like this chick is just your classic like college girl that took a pill and didn't know what it was or something, you know." This female was later identified Madison Mogen (Mogen).

C. [REDACTED] [REDACTED] and another male left Corner Club at approximate closing time and went to the Grub Truck, a food truck located in Moscow, Idaho. After they got to the Grub Truck, he noticed Mogen arrive with another female, who was later identified as Kaylee Goncalves (Goncalves). Mogen appeared extremely intoxicated, to the point she was falling against the Grub Truck repeatedly. He noticed a male standing near Mogen and Goncalves and believed he was there with them. This male was later identified as [REDACTED] [REDACTED] ([REDACTED]).

D. He had a conversation with [REDACTED] at the Grub Truck. [REDACTED] said he was there just to make sure the girls got home safe. [REDACTED] asked him how he felt about being recorded and then pointed out the livestream recording on the Grub Truck. They continued talking about inconsequential topics, like cars, the weather, how their night was going, etc.

E. It seemed like [REDACTED] knew a group of fraternity guys who were waiting at the Grub Truck. Mogen and Goncalves were whispering to each other, looking at [REDACTED] and giggling. He thought [REDACTED] was in the "Friendzone", when describing the dynamic between the three. He felt like [REDACTED] was annoyed with the girls, saying he kept shaking his head at them, taking deep breaths, and sighing.

F. A blue car, possibly a Honda, eventually pulled up near the Grub Truck and he saw Mogen and Goncalves get

into it and leave. He was unaware of [REDACTED] location or actions until he reviewed the recorded livestream footage later but had initially thought he left with them in the car.

2. The audio/video interview was downloaded and turned over to Moscow Police Department evidence.
