Summary Narrative

The victims were identified as Kaylee Goncalves (GONCALVES), Madison Mogen (MOGEN), Xana Kernodle (KERNODLE), and Ethan Chapin (CHAPIN).

I, ISP Detective (Det.) Jeffory R. Talbott was assigned as the lead crime scene investigator. On November 19 and 20, 2022, ISP personnel returned to the scene for further processing and evidence collection. All items collected were turned over to MPD.
