**Narrative**

- On November 18, 2022, at approximately 0910 hours, I, Idaho State Police (ISP) Detective Timothy Snell, and ISP Detective Andy Hodl contacted [REDACTED] (DOB [REDACTED]/2002) regarding the homicide investigation located at 1122 King Street, Moscow, Idaho. The interview was conducted by phone and it was audio recorded.
- [REDACTED] stated she was at the lodge party with Xana Kernodle and Ethan Chapin on the night prior to the homicide and they discussed going to Applebee's the following day. [REDACTED] stated nothing was out of the ordinary throughout the evening.
- [REDACTED] stated she knew everyone in the Twitch video with Kaylee Goncalves and Madison Mogen. [REDACTED] named [REDACTED] and stated he was a [REDACTED] fraternity member providing sober rides. [REDACTED] named a second person in the video as [REDACTED] said she heard [REDACTED] and [REDACTED] drove Goncalves and Mogen home. [REDACTED] said both [REDACTED] and [REDACTED] called in to the tip hotline to advise law enforcement. [REDACTED] stated she heard a person named [REDACTED] stopped by the King Street residence to meet with Kernodle. [REDACTED] is also a [REDACTED] and is dating [REDACTED].
- [REDACTED] stated she was primarily friends with Kernodle and her friend group and was not close with Goncalves and Mogen.
- During follow up questioning, [REDACTED] explained the lodge parties always end at one (1:00) and she last spoke with Kernodle between twelve forty-five (12:45) and one (1:00) that morning. According to [REDACTED] the lodge party was tame and not very many people attended due to the short duration of planning for it.

**Narrative**

6. During the interview, a second individual could be heard in the background, and she identified herself as ██████████ (DOB ████████/2003). ██████████ stated she also attended the lodge party and was with ██████████. Both ██████████ and ██████████ stated there was nothing out of the ordinary throughout the evening or night. When asked questions regarding observing anything unusual, both ██████████ and ██████████ were not directly aware of anything.
7. ██████████ provided phone number ██████████ for ██████████ and ██████████ for ██████████. ██████████ stated her phone number was ██████████.
8. Based upon the responses, both ██████████ and ██████████ were referred for a follow up interviews by victimology.
9. The audio recording of the phone interview was turned over to the Moscow police department labeled D22000030\_0078.
