### Narrative

1. On November 17, 2022, I, Detective Andy Hodl of the Idaho State Police conducted numerous interviews by phone in relation to tips received for this investigation. The people interviewed are listed below along with their phone number. All phone calls were digitally recorded, and the recordings have been turned over to the Moscow Police Department.

- (aka (DOB: 1999) phone number on 11/17/2022 at 0957 hours with Detective Hodl and Detective Clark.

- (DOB: /2002) phone number on 11/17/2022 at 1053 hours with Detective Hodl and Detective Herman.

2. On 11/17/2022 at approximately 0957 hours, Detective Andy Hodl and Detective Brittany Clark spoke to [REDACTED] [REDACTED] via recorded phone call.
  3. [REDACTED] stated she was in the social media video at the food truck where Kaylee Goncalves and Madison Mogen were seen. [REDACTED] said she did not remember any interaction with Goncalves and Mogen.
  4. [REDACTED] said she was there with a friend named [REDACTED] who was later identified as [REDACTED] [REDACTED] and had already been interviewed by another detective. [REDACTED] said she was also there with another male named [REDACTED] but did not know his last name.
  5. [REDACTED] said she was just calling because she saw herself in the video on the news and did not want police to have to track her down.
  6. No further information at this time.
  7. On 11/17/2022 at approximately 1053 hours, Detective Andy Hodl and Detective Cody Herman spoke to [REDACTED] [REDACTED] via recorded phone call.
  8. [REDACTED] said she was at the Starbucks in Moscow when she got a text alert from Washington State University where she is a student alerting her to the homicide in Moscow. [REDACTED] went on to say that another female standing next to her got a text alert from University of Idaho stating to shelter in place.
  9. [REDACTED] did not know who this female was but said that the female stated she had seen a bloody knife outside of the [REDACTED] in Moscow in a drainpipe. The female told [REDACTED] she had reported what she saw to a [REDACTED] employee.
  10. [REDACTED] described the female as 5'2 to 5'4 blondish brown hair and had a [REDACTED] tattoo. I later contacted [REDACTED] and spoke to a manager. The manager checked and later advised me there was no record of anyone reporting finding a knife. She assured me that they would have called police.
  11. The exterior of [REDACTED] was also searched by myself and several other detectives during the evening of November 16, 2022, and nothing of interest was located.
  12. No further information at this time.
  13. On 11/17/2022 at approximately 1211 hours, Detective Andy Hodl and Detective Brittany Clark spoke to [REDACTED] [REDACTED] via recorded phone call.
  14. [REDACTED] stated his [REDACTED] was a Washington State University student and he and his wife were visiting for [REDACTED] [REDACTED]
  15. [REDACTED] told me that his daughter and wife noticed a male following them while inside the [REDACTED] in Moscow on the evening of Friday November 11, 2022. [REDACTED] said his wife initially thought it was a loss prevention employee but after hearing about the homicides in Moscow, he felt he needed to call and advise about this male.
  16. Idaho State Police Sergeants Sproat and Klitch collected surveillance video from [REDACTED] and it has been submitted to evidence.
  17. No further information at this time.
  18. On 11/17/2022 at approximately 1315 hours, Detective Andy Hodl and Detective Brittany Clark spoke to [REDACTED] [REDACTED] via recorded phone call.

19. [REDACTED] said approximately three years ago she had an employee at her [REDACTED] business in South Dakota named [REDACTED]

20. [REDACTED] said they had a dispute over money, and she saw through security cameras as [REDACTED] became angry and began breaking things in the kitchen while holding a knife. [REDACTED] said she was afraid of [REDACTED] and that he had mental issues.

21. [REDACTED] now lives in Moscow but has not had contact with [REDACTED] in three to four years.
