- On November 19, 2022, I, Idaho State Police Detective Leslie Lehman conducted a phone interview with [REDACTED] member [REDACTED] [REDACTED] was identified as the [REDACTED] of the [REDACTED] at the University of Idaho campus.
- [REDACTED] was located at home in Tri-Cities, Washington when I called him. I asked [REDACTED] about the [REDACTED] party the night of November 12, 2022. [REDACTED] confirmed there was a party at the [REDACTED] house and there was a guest list for the party. [REDACTED] said there was a ratio of two guests allowed for every [REDACTED] member. [REDACTED] explained the security measures the fraternity uses to avoid people being able to sneak into the party. The [REDACTED] is the area in the fraternity house where events are held. [REDACTED] said the party went from 09:30 p.m.

Narrative

19. [REDACTED] said the same about Xana regarding her being a happy person without enemies. [REDACTED] has known Xana since his freshman year.
20. [REDACTED] could not speak to issues with Xana's security around the area or her apartment. [REDACTED] felt Ethan would spend the night at Xana's due to the distance to his own apartment and not because she was experiencing security issues at her apartment.
21. [REDACTED] has met Kaylee Goncalves and Madison Mogen but did not know them well. [REDACTED] said the same for [REDACTED] and [REDACTED].
22. [REDACTED] was last at the 1122 King Street address on the Friday prior to the homicide. He spent fifteen to twenty minutes there playing "Pong" then went to the [REDACTED].
23. [REDACTED] emailed me the [REDACTED] party attendance list and a timeline he had established regarding the night of November 12, 2022, and the interaction with Ethan and Xana and the [REDACTED] members. The documents were forwarded to ISP Detective Ryan O'Harra for further investigation.
24. The audio of the interviews conducted, the emails exchanged with [REDACTED] and the screen shots of the text messages exchanged with [REDACTED] have been saved to disc and will be given to Moscow Police Department as an attachment to this supplement.
