On November 17, 2022, at 1050 hours, I, Idaho State Police (ISP) Detective Leslie Lehman along with ISP Detective Brittany Clark went to the [REDACTED] located at [REDACTED], Moscow, Idaho. [REDACTED] was walking out the door and told me he was the last of two (2) occupants in the building. [REDACTED] (DOB [REDACTED] 2001) spoke to me about his knowledge of the victims in this case.

Former [REDACTED] member [REDACTED] (DOB [REDACTED] /2000) was interviewed at his home on November 18, 2022. [REDACTED] (DOB [REDACTED] /2004) was interviewed by phone on November 18, 2022.

## Narrative

1. On November 17, 2022, at 1050 hours, I, Idaho State Police (ISP) Detective Leslie Lehman along with ISP Detective Brittany Clark went to the ██████████ located at ██████████ Moscow, Idaho. ██████████ was walking out the door and told me he was the last of two (2) occupants in the building, the others had left to return home. ██████████ said he was away at a ██████████ game over the weekend of November 12, 2022. ██████████ said fraternity brothers ██████████ and ██████████ were also on the ██████████ and out of town. ██████████ said ██████████ was the ██████████ and was out of town.
2. The last occupant in the building, ██████████ (DOB ██████████/2001), came to the front door to speak to me. ██████████ said he knew the female victims and they had been to his fraternity house on many occasions. ██████████ said he is a ██████████ and saw the victims the night prior to the homicide. ██████████ believed the video evidence from the ██████████ had been secured by law enforcement. ██████████ could not recall anything that would be helpful to the investigation.
3. On November 18, 2022, the FBI staff was given the previous information and agreed to start calling the members of the ██████████ and securing their information and current location. It was discovered ██████████ (DOB ██████████/2000) was still in the Moscow area. I called ██████████ and he agreed to meet me at his residence located at ██████████, Moscow, Idaho on the University of Idaho (U of I) Campus.
4. At 1130 hours, ISP Detective Jacob Schwecke and I met with ██████████ said he is not a member of ██████████ anymore.
5. ██████████ said he knew victim Ethan J. Chapin and knew he was a ██████████ ██████████ knew victim Xana Kernodle and had attended parties with her. ██████████ knew victim Kaylee Goncalves through his girlfriend, ██████████. ██████████ knew victim Madison "Maddie" Mogen through his ██████████
6. ██████████ said he was inebriated the evening of 11/12/2022. ██████████ remembered seeing Kaylee and Maddie at the club. ██████████ was unsure of the exact times but believes it was 0100 hours on 11/13/2022 when he was picked up by the "Sober Bro" ██████████ ██████████ thinks he went to the ██████████ convenience store and purchased alcohol. From the ██████████ took ██████████ home. ██████████ spent the rest of the evening at home with roommate ██████████ his girlfriend ██████████ and her friend ██████████
7. The last time ██████████ was at the crime scene at 1122 King Street was last semester, spring of 2022.
8. ██████████ considers ██████████ a good guy and knew he was not in Moscow the weekend of November 12, 2022.

9. On November 18, 2022 at 1630 hours, I called ██████████ (DOB ██████████ 2004) ██████████. ██████████ said he was in Boise, Idaho but agreed to speak to me via phone. The call was recorded.

10. ██████████ confirmed he was the sober driver for the ██████████ ██████████ on the evening of November 12, 2022, starting at 1700 until approximately 0200 hours on November 13, 2022. ██████████ uses his phone and riders send him texts or call him to give them rides. ██████████ said uses his own vehicle, a ██████████, Idaho plate ██████████

11. ██████████ said the night consisted of taking riders to the football game, the ██████████ apartments (██████████, Moscow, Idaho), ██████████ and back to the ██████████ house. ██████████ also confirmed he returned ██████████ and ██████████ to their home, ██████████.

12. ██████████ said the party at the ██████████ appeared to have 20-30 people, but he did not go into the party. ██████████ gave a verbal run down of his text messages and who he gave rides to. Notably, ██████████ said he gave a ride to ██████████ to the ██████████ at 2130 hours. ██████████ said everyone he gave a ride to he returned back to the ██████████ house. ██████████ confirmed he returned ██████████ and ██████████ to their home, ██████████. ██████████ said ██████████ was the only person he gave a ride to the ██████████ at 2130 hours. ██████████ did not give ██████████ a ride to his home off campus. ██████████ knows ██████████ lives near the homicide scene in an apartment.
