## Narrative

2. explained he knew from school as they played football together in 2000. Osborn stated he had not seen in a long time since then but, ran into him in a store in Potlatch, Idaho about two months ago. During that interaction, said they exchanged some pleasantries told he was working in Moscow Idaho. After a short conversation, the two went their separate ways.
3. On November 17, 2022, at approximately 1715 hours, arrived home to see outside of his house. appeared to be looking for something using the flashlight on his phone. said his parents were not home at that time and his house was not equipped with cameras.
4. said he got out of his truck, hugged and they decided to talk in truck as it was still running and warm. was a said had his tools and chainsaw with him and needed to move it to make room for to sit. told he had recently learned how to use a chainsaw and was feeling the blade of saw. told his blade felt dull, and he should sharpen it. made room for and the two of them got into the truck to stay warm.
5. Stated they spoke in the truck for approximately 25-30 minutes. During that time, drinking and partying all the time, only had one friend (who knew to be unknown spelling of last name DOB 2000) and wanted to hire him as a record.
6. told Detective Herman and I his conversation with appeared to be a cry for help, as if he might have done something bad, or he may be suicidal. It is not
told Detective Herman a least got out of his truck and went to his car as girlfriend was pulling up. proceeded to throw up before driving away from house. waited a little bit then drove to the church and saw car (what he described as a green Honda Civic bearing ldaho license plate plate) parked at the church. did not go inside the church, he only took a picture of license plate, and left.
8. At the time of the interview, had not spoken to since that day. told Detective Herman and I he had nothing else to add at that time but was available for follow up if needed.
9. After a law enforcement records check, was identified as (DOB: 2000).  1. It is a teal registered to him bearing Idaho license plates last known address was Potlatch, Idaho.
