Narrative

1. On November 19, 2022, at approximately 1121 hours, I, Idaho State Police Detectives Matthew Heinle along with Detective Cody Herman conducted an interview with [REDACTED] (DOB [REDACTED]/1998) at the Moscow Police Department. [REDACTED] sought out police for a voluntary interview. [REDACTED] told Detectives he lived with his parents at [REDACTED], Princeton, Idaho, and his phone number was [REDACTED]. [REDACTED] felt he needed to tell the police about a strange encounter he had with [REDACTED].

Narrative

2. [REDACTED] explained he knew [REDACTED] from school as they played football together in 2000. Osborn stated he had not seen [REDACTED] in a long time since then but, ran into him in a store in Potlatch, Idaho about two months ago. During that interaction, [REDACTED] said they exchanged some pleasantries [REDACTED] told [REDACTED] he was working as a [REDACTED] in Moscow Idaho. After a short conversation, the two went their separate ways.
3. On November 17, 2022, at approximately 1715 hours, [REDACTED] arrived home to see [REDACTED] outside of his house. [REDACTED] appeared to be looking for something using the flashlight on his phone. [REDACTED] said his parents were not home at that time and his house was not equipped with cameras.
4. [REDACTED] said he got out of his truck, hugged [REDACTED] and they decided to talk in [REDACTED] truck as it was still running and warm. [REDACTED] was a [REDACTED] and had his tools and chainsaw with him and needed to move it to make room for [REDACTED] to sit. [REDACTED] told [REDACTED] he had recently learned how to use a chainsaw and was feeling the blade of [REDACTED] saw. [REDACTED] told [REDACTED] his blade felt dull, and he should sharpen it. [REDACTED] made room for [REDACTED] and the two of them got into the truck to stay warm.
5. [REDACTED] told Detective Herman and I [REDACTED] was drunk as he could smell it and [REDACTED] was moving slowly. [REDACTED] stated they spoke in the truck for approximately 25-30 minutes. During that time, [REDACTED] told him he was drinking and partying all the time, only had one friend (who [REDACTED] knew to be [REDACTED] [REDACTED] unknown spelling of last name DOB [REDACTED]/2000) and wanted [REDACTED] to hire him as a [REDACTED]r.
6. [REDACTED] told Detective Herman and I his conversation with [REDACTED] appeared to be a cry for help, as if he might have done something bad, or he may be suicidal. [REDACTED]r told [REDACTED] he was tired and was going to go eat dinner at the local [REDACTED] church. As [REDACTED] went to get out of his truck, his brown coat lifted, and [REDACTED] saw [REDACTED] had what appeared to be a knife on his belt positioned at his back. [REDACTED] said the knife looked like a folding type and was in a leather pouch with a top flap button closure. This made [REDACTED] feel very uneasy.
7. [REDACTED] told Detective Herman a I [REDACTED] got out of his truck and went to his car as [REDACTED] girlfriend was pulling up. [REDACTED] proceeded to throw up before driving away from [REDACTED] house. [REDACTED] waited a little bit then drove to the [REDACTED] church and saw [REDACTED] car (what he described as a green Honda Civic bearing Idaho license plate [REDACTED]) parked at the church. [REDACTED] did not go inside the church, he only took a picture of [REDACTED] license plate, and left.
8. At the time of the interview, [REDACTED] had not spoken to [REDACTED] since that day. [REDACTED] told Detective Herman and I he had nothing else to add at that time but was available for follow up if needed.
9. After a law enforcement records check, [REDACTED] was identified as [REDACTED] [REDACTED] (DOB: [REDACTED] 2000). [REDACTED] has a teal [REDACTED] registered to him bearing Idaho license plates [REDACTED]. [REDACTED] last known address was [REDACTED] Potlatch, Idaho.
