- On November 18, 2022, Idaho State Police Detective Sergeant Hoxie and I, Detective Pesina interviewed University of Idaho student [REDACTED] (D.O.B. [REDACTED]/2000). [REDACTED] had her [REDACTED] present for the interview.
- I asked [REDACTED] to explain her day. [REDACTED] stated the following:
- [REDACTED] said it was game day (College Football). Her and her friends attended a pre-game at the [REDACTED] Apartment Complex at approximately 3:00 P.M. She remembers talking to Madison Mogen and Kaylee Goncalves

- at the pre-game and was sure she saw the rest of the roommates there. [REDACTED] remembers seeing Xana as well.
4. At approximately 3:50 P.M., [REDACTED] said she left the pre-game and went to the game that started at 4:00 P.M.
5. [REDACTED] said she was going to help Goncalves get a ticket for the game. Goncalves decided to not go to the game because Mogen was not going.
6. After the game, [REDACTED] said they went to a place called [REDACTED] Goncalves texted [REDACTED] and asked if she was going to the Corner Club. [REDACTED] said they would go after the fights on T.V. were over.
7. At approximately 10:59, Goncalves texted [REDACTED] asking if she needed a ride. Goncalves text read, "me, Madie and [REDACTED] are getting one so we can pick you up." [REDACTED] said she was at the Corner Club when she saw the message.
8. At approximately 10:30 to 11:00 P.M., [REDACTED] saw Mogen and Goncalves at the Corner Club.
9. At approximately 11:30 P.M. to 12:00 A.M., [REDACTED] left the Corner Club with her other friend and boyfriend and went home.
10. [REDACTED] said after they got home, her friend [REDACTED] was drunk, and she was trying to put her to bed. Her boyfriend went to bed in her room.
11. I asked [REDACTED] how well she knew the victims. [REDACTED] said she met Mogen her freshman year and knew her through mutual friends. [REDACTED] said she met Goncalves her freshman year and were both in the same sorority. [REDACTED] said Goncalves was her best friend. [REDACTED] said she did not know Xana Kernodle as well. [REDACTED] described her as being a big party girl and would attend the same parties as her. Kernodle was best friends with a lot of the [REDACTED]
12. I asked if Goncalves ever mentioned if she was ever followed or talked about some weird activity recently. [REDACTED] said Goncalves had never mentioned that to her.
13. I asked [REDACTED] if Goncalves had anybody who had any issues with her. [REDACTED] said Goncalves never mentioned it to her.
14. [REDACTED] said Goncalves was the type to go out and meet random people at places like John's Ally and would get rides from random people.
15. [REDACTED] said Goncalves and [REDACTED] [REDACTED] had broken up recently after a long relationship.
16. I asked [REDACTED] where her house was in relation the victims house. [REDACTED] said both houses shared a back yard with a chain-link fence separating the two yards.
17. Sgt. Hoxie asked if she heard any strange noises. [REDACTED] said she did not.
18. I asked [REDACTED] if Goncalves had always stayed at the same apartment. [REDACTED] said Goncalves had stayed there all summer. [REDACTED] said Goncalves room in the summer was on the main floor. At the end of the summer, Goncalves moved into [REDACTED] [REDACTED] room upstairs.
19. [REDACTED] said she had heard from one of the girls' friends, they went to Coeur d'Alene for a week and when they returned, they noticed the rear sliding glass door was open. [REDACTED] did not know the date of the incident.
20. Sgt. Hoxie asked about drug use. [REDACTED] said she never saw Goncalves or Mogen do drugs. She said she wasn't sure about Kernodle. She said they probably had but it wasn't anything that was prominent.
21. [REDACTED] said we should talk to some of Kernodle's friends, [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED]
22. I asked if there was any other information she feels we should know or any other people we should talk to. [REDACTED] said we should speak with [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED]
