The interview took place at the Idaho State Police District 3 Office, located at 700 S. Stratford Drive, Meridian, Idaho.
reported the following during the interview:
3. He lived at, Moscow, Idaho, while attending the University of Idaho. His house was across the street from where the homicide occurred.
He knew Kaylee Goncalves since her freshman year at the university. Goncalves also dated his friend and him were in ' (fraternity) together. Goncalves was in (sorority) which was down the road from his fraternity. He wasn't extremely close to Goncalves but was friends with her.
and Goncalves had been dating since their sophomore year in high school. He thought they attended take City High School in Coeur d'Alene, Idaho. and Goncalves had been dating on and off for the last ew months because Goncalves was moving to Texas or North Carolina after the semester. He didn't think wanted to break up with Goncalves, but was understanding. He thought Goncalves initiated the breakup. There wasn't any turmoil in their relationship, and they were still talking and hanging out together. Goncalves and also had a dog together which lived at his house last year.
didn't talk to him about his relationship with Goncalves. worked at the might have quit the
7. He also knew the other victims, Madison Mogen, and Xana Kernodle. Kernodle had gone over to his house a few times to see his roommate, from last year but transferred schools to transferred.
B. He didn't really talk to Mogen but knew her by first name. The other two girls, were younger and he didn't really know them. He didn't know Ethan Chapin.
P.His house was three stories where he lived with and lived in the top floor of the house.
He never noticed anything out of place near his house or the victim's house.
11. On November 12th, 2020, the University of Idaho's football team was playing UC Davis at home at 4:00 P.M. He woke up that day, got some food, and started tailgating for the game. After tailgating, he went home and then went out to the bars.
12. At approximately 11:00 P.M., he got to the Corner Club. While he was at the Corner Club, he saw Goncalves out couldn't remember if she was with anyone. At approximately 12:30 A.M. a sober member from his fraternity arrived to drive and him home. As they were leaving the Corner Club, they were pulled over for an expired registration. The cops let them go and he was driven home.
13. At his house, he hung out and drank beers with the state of the st
14. He never heard anything of Goncalves having a stalker until after her death. Goncalves worked at where he heard she had a weird person coming in for her. He heard this information from
15. He also heard from his girlfriend, Goncalves had a weird guy following her around WinCo earlier hat week. This information was from a third party.
16. He wasn't aware of any of the victims' using drugs. He and his roommates
