## Narrative

1. On November 18th, 2022, at approximately 11:34 A.M., Idaho State Police Detective Pesina and I conducted an interview with [REDACTED] [REDACTED]. The interview was in reference to the murder of Madison Mogen, Kaylee Goncalves, Xana Kernodle and Ethan Chapin, which occurred at 1122 King Road, Moscow, Idaho, on November 13th, 2022. The interview took place at the Idaho State Police District 3 Office, located at 700 S. Stratford Drive, Meridian, Idaho.

2. [REDACTED] reported the following during the interview:

3. He lived at [REDACTED], Moscow, Idaho, while attending the University of Idaho. His house was across the street from where the homicide occurred.

4. He knew Kaylee Goncalves since her freshman year at the university. Goncalves also dated his friend [REDACTED] [REDACTED] and him were in [REDACTED] (fraternity) together. Goncalves was in [REDACTED] (sorority) which was down the road from his fraternity. He wasn't extremely close to Goncalves but was friends with her.

5. [REDACTED] and Goncalves had been dating since their sophomore year in high school. He thought they attended Lake City High School in Coeur d'Alene, Idaho. [REDACTED] and Goncalves had been dating on and off for the last few months because Goncalves was moving to Texas or North Carolina after the semester. He didn't think [REDACTED] wanted to break up with Goncalves, but [REDACTED] was understanding. He thought Goncalves initiated the breakup. There wasn't any turmoil in their relationship, and they were still talking and hanging out together. Goncalves and [REDACTED] also had a dog together which lived at his house last year.

6. [REDACTED] didn't talk to him about his relationship with Goncalves. [REDACTED] worked at the [REDACTED] and the [REDACTED]. He thought [REDACTED] might have quit the [REDACTED].

7. He also knew the other victims, Madison Mogen, and Xana Kernodle. Kernodle had gone over to his house a few times to see his roommate, [REDACTED] [REDACTED] from last year but [REDACTED] transferred schools to [REDACTED]

8. He didn't really talk to Mogen but knew her by first name. The other two girls, [REDACTED] and [REDACTED], were younger and he didn't really know them. He didn't know Ethan Chapin.

9. His house was three stories where he lived with [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. He and [REDACTED] lived in the top floor of the house.

10. He never noticed anything out of place near his house or the victim's house.

11. On November 12th, 2020, the University of Idaho's football team was playing UC Davis at home at 4:00 P.M. He woke up that day, got some food, and started tailgating for the game. After tailgating, he went home and then went out to the bars.

12. At approximately 11:00 P.M., he got to the Corner Club. While he was at the Corner Club, he saw Goncalves but couldn't remember if she was with anyone. At approximately 12:30 A.M. a sober member from his fraternity arrived to drive [REDACTED] and him home. As they were leaving the Corner Club, they were pulled over for an expired registration. The cops let them go and he was driven home. [REDACTED] [REDACTED] and [REDACTED] got home about 30 minutes after him.

13. At his house, he hung out and drank beers with [REDACTED] [REDACTED] [REDACTED] and [REDACTED] girlfriend, [REDACTED] [REDACTED]. After hanging out, he went to bed which was early for him.

14. He never heard anything of Goncalves having a stalker until after her death. Goncalves worked at [REDACTED] where he heard she had a weird person coming in for her. He heard this information from [REDACTED]

15. He also heard from his girlfriend, [REDACTED] [REDACTED] Gonçalves had a weird guy following her around WinCo earlier that week. This information was from a third party.

16. He wasn't aware of any of the victims' using drugs. He and his roommates [REDACTED]

17. He never texted or called Goncalves.

18. He wasn't aware of any recent parties at the victim's house.

19. He wanted us to know that [REDACTED] heard a dog barking around 4:00 A.M. [REDACTED] reported it to the police the following day after the incident.

20. [REDACTED] did not have injuries to his hands, arms, or face.

21. At approximately 11:56 A.M., we concluded the interview.
