Narrative

1. On November 18, 2022, at approximately 11:36 AM, Homeland Security Investigations Task Force Officer (TFO) Sage Collins and I, Idaho State Police Detective Matt Wernsing, interviewed [REDACTED] [REDACTED] (DOB [REDACTED]/2000) in regard to the homicide of Kaylee GONCALVES, Madison MOGEN, Xana KERNODLE, and Ethan CHAPIN. The interview took place at [REDACTED] home, located at [REDACTED] in Parma, Canyon County, Idaho. The following is summary of [REDACTED] statement:
2. [REDACTED] was a friend of GONCALVES and MOGEN and was also their neighbor across the street at [REDACTED] King Rd in Moscow, Latah County, Idaho. He did not know the other two victims. GONCALVES was in an on-and-off dating relationship with one of [REDACTED] roommates [REDACTED] [REDACTED] and [REDACTED] were in the same fraternity. [REDACTED] also knew MOGEN's boyfriend, but he had graduated and was living in Boise. He knew GONCALVES a little more than MOGEN because she had dated [REDACTED] and he said their relationship remained amicable.
3. [REDACTED] and his girlfriend [REDACTED] [REDACTED] were at his house on Saturday, November 12. [REDACTED] went to the victims' house around 10:00 PM. At approximately 10:45 PM, [REDACTED] GONCALVES, and MOGEN got a ride to the Corner Club bar, located at 202 N Main St in Moscow. [REDACTED] believed they got a ride from an Uber driver named [REDACTED]. He and his friends went to the Corner Club shortly after the girls left.
4. After approximately an hour, [REDACTED] spoke with GONCALVES and MOGEN briefly while at the Corner Club before they left. [REDACTED] told [REDACTED] the two girls were going to John's Alley Tavern, located at 114 E 6th St in Moscow.
5. [REDACTED] saw they were hanging out with another student he identified as [REDACTED] [REDACTED] and saw them leave the Corner Club with [REDACTED] [REDACTED] told [REDACTED] the two girls did not typically hang out with [REDACTED] and [REDACTED] thought it was odd.
6. [REDACTED] and [REDACTED] walked to [REDACTED] house at approximately 1:30 AM and stayed there. They woke up the next morning, Sunday, November 13, went and got breakfast, and [REDACTED] drove [REDACTED] to his house at approximately 11:45 AM. There was only one Police vehicle in front of the residence when they drove by. [REDACTED] went outside with [REDACTED] and another roommate, [REDACTED] [REDACTED] and watched more law enforcement respond to the scene. [REDACTED] ran to the victim's house and was there for approximately an hour and a half before returning. [REDACTED] was visibly upset and told [REDACTED] and [REDACTED] some of the girls had died and GONCALVES was one of them.
7. [REDACTED] left Moscow later on Sunday.
8. [REDACTED] clarified he and [REDACTED] went to the Grub Truck on their way from the Corner Club to [REDACTED] house. He also saw on social media GONCALVES and MOGEN went to the Grub Truck after he [REDACTED] were there. [REDACTED] thought they may have been at the Grub Truck between 3-3:30 AM based on when they posted to their social media. The Grub Truck broadcasted a live feed that captured the two girls at the truck.
9. [REDACTED] thought it was odd that [REDACTED] spent so much time around the two girls.
10. [REDACTED] had heard [REDACTED] may have committed the murder, but said [REDACTED] went home with their other roommates [REDACTED] and [REDACTED] when he and [REDACTED] left the Corner Club. [REDACTED] fourth roommate [REDACTED] [REDACTED] worked at [REDACTED], but would have gone home around 4 AM after closing down [REDACTED]. There were also two more students that lived above [REDACTED] [REDACTED] [REDACTED] and [REDACTED] that were hanging out with [REDACTED] [REDACTED] and [REDACTED] before they all went to bed.
11. [REDACTED] told [REDACTED] he had been woken up between 4-4:45 AM because [REDACTED] and GONCALVES's dog had been barking very loudly and uncontrollably. It sounded as though the dog was outside, which was odd because of how cold it was and the dog not being an "outside dog."
12. [REDACTED] did not know the two roommates that were not injured and found it odd that they were sitting in their rooms and slept through the incident.
13. [REDACTED] was not aware of any of the victims had a stalker. He mentioned a stalker from earlier in the year

that lived in " apartments that had already been reported to the police.

14. The interview was concluded at 12:09 PM. For further details from statement, see notes and listen to audio recording of interview.

15. I transferred the audio recording of the interview to a CD and submitted into ISP Evidence under Tag #220004202
