## **Narrative**

- 2. She lived at King Rd across the street from the 1122 King Rd house. One of the people across the street was a former sorority sister, one was a classmate, and the other two were people she knew through mutual friends. She knew (Madison) MOGEN and (Kaylee) GONCALVES the best.
- 3. Her boyfriend was best friend's with MOGEN's boyfriend ( so they hung out a lot. This was a current relationship. MOGEN was in a class with her.
- 4. GONCALVES was an sorority sister.
- 5. She knew (Xana) KERNODLE and (Ethan) CHAPIN in passing.
- 6. She has lived at King Rd for just the semester and is currently a senior in school. She lived in the sorority house for three years and this is the first year outside of the sorority.
- 7. She has been inside the 1122 King Rd house multiple times with the last time being in September. They came over to her house more often.
- 8. She had known MOGEN and GONCALVES for three years. They met through recruitment.
- 9. She saw MOGEN and GONCALVES Saturday night (November 12th). They went to the Corner Club after the game. MOGEN and GONCALVES were already there when she arrived. She was there for a couple of hours and was really drunk. She left before MOGEN and GONCALVES. It was sometime around midnight.
- 10. GONCALVES had jokingly mentioned she thought she had a stalker at Winco. It had happened once and was an unknown person.
- 11. She heard from another friend an instance of the house door at 1122 King Rd being open after all the roommates returned from a weekend trip.
- 12. She has a basement room and can see the 1122 King Rd house from it. She woke up at 9:00 AM on Sunday morning. She didn't hear or see anything that night.
- 13. 1122 King Rd didn't have a party on Saturday night. They may have had one on Friday but it wasn't crazy.
- 14. MOGEN and were a solid couple and had dated for a year. was with her boyfriend in Boise that weekend.
- 15. The interview concluded at 12:52 PM.
