### Narrative

1. On November 18, 2022, at approximately 12:53 PM, Idaho State Police Investigations Lieutenant Catlin and I, interviewed [REDACTED] regarding multiple homicides which took place in Moscow, Idaho. The interview took place at the [REDACTED] in Boise, Idaho. During the interview, [REDACTED] stated the following:

2. She left University of Idaho in May 2021. She belonged to the [REDACTED] sorority and Madison MOGEN was her best friend. She was also friends with Kaylee GONCALVES, Xana KERNODLE, Ethan CHAPIN, [REDACTED], and [REDACTED]

3. She became close with KERNODLE the year before she left University of Idaho. She had gone up to Moscow

and seen all of them recently for Homecoming in October 2022. She knew GONCALVES through MOGEN. She had met CHAPIN once or twice through KERNODLE. She did not know [REDACTED] or [REDACTED] as well; she had only met them a few times.

4. She received a FaceTime call from MOGEN the night of the homicides at approximately 1:50 AM, Boise time. [REDACTED] was drunk at the time of the call, MOGEN appeared to be also. The call only lasted approximately 1 minute. [REDACTED] was with [REDACTED] and [REDACTED] during the call at a bar in Boise. MOGEN was with GONCALVES at the Corner Club in Moscow during the call.

5. [REDACTED] had run into MOGEN's boyfriend, [REDACTED] at a bar called "Amsterdam Lounge" in Boise. [REDACTED] took a picture with [REDACTED] at the bar at approximately 1:15 AM, [REDACTED] and [REDACTED] were also in the photo. I confirmed the date and time stamp on the photo as being from the night of the homicides.

6. She had been with [REDACTED] and some of the other friends every day since the homicides. She had seen [REDACTED], and others since the homicides. Monday, November 14th, [REDACTED], [REDACTED] and others had come over after they arrived back in Boise. [REDACTED] parents met her in Boise and [REDACTED] went back home with them.

7. The last social media post [REDACTED] had seen with any of the victims was a picture of MOGEN on GONCALVES Snapchat story. They were at the Grub Truck together.

8. She knew the person in the video at Grub Truck was [REDACTED]. She did not know him well. [REDACTED] had a girlfriend the whole time [REDACTED] was going to school at University of Idaho. She knew [REDACTED] girlfriend, [REDACTED] better than him. [REDACTED] and that girlfriend are not dating anymore. [REDACTED] lived at the brown apartments near the victims. She heard a rumor that [REDACTED] has anger issues. She heard another rumor that [REDACTED] hunts.

9. When she was up in Moscow during Homecoming, she went to the victim's house, but did not go inside. The last time she was in the victim's house was December 2021. Different girls were living in the house then. She knew where each of the victim's rooms were in the house. The room near the kitchen was [REDACTED]. The room by the bathroom upstairs, but still on the main level, was KERNODLE's. The room downstairs, when you first walk in, was [REDACTED]. The room next to [REDACTED] was vacant, but [REDACTED] was paying rent. The room upstairs with the sliding glass door and the balcony was GONCALVES. The tiny room upstairs with just a window to the balcony was MOGEN's. MOGEN is the only one who lived there for two years, and she stayed in that room the whole time. When she lived in Moscow, everyone used the front door to go in and out of the house.

10. [REDACTED] and [REDACTED] were called by [REDACTED] and [REDACTED] the next morning. [REDACTED] went upstairs and saw some of what happened. At the time of the interview, [REDACTED] and [REDACTED] were in Mexico.

11. She thought [REDACTED] and [REDACTED] called [REDACTED] and [REDACTED] because they were a little worried. Their other roommates weren't answering. [REDACTED] thought she had heard someone in the house the night before and wasn't sure if that person was still in the house. During [REDACTED] time living in Moscow, it wasn't uncommon for someone to walk into the wrong house drunk, or to hear people up and moving around, in which case you might call someone you know instead of the police.

12. [REDACTED] told [REDACTED] she heard GONCALVES playing music earlier that night at approximately 4:00 AM. She ended up going down to [REDACTED] room, because [REDACTED] was the only one who answered. They had all been drinking all day, the day before, and [REDACTED] was a little freaked out that someone might be in the house.

13. She does not believe any of the victims used drugs.

14. MOGEN and KERNODLE were servers at [REDACTED]. GONCALVES was about to finish school.

15. Since the homicides, [REDACTED] and [REDACTED] told [REDACTED] a story about MOGEN, GONCALVES and KERNODLE going to Winco. GONCALVES went in. GONCALVES felt like someone was following her/lurking

around. This freaked GONCALVES out enough to go get back in the car and lock the doors immediately. A man then tried to open the car door. This happened approximately 2-3 week prior to the interview.

16. Since the homicides, [REDACTED] and [REDACTED] told [REDACTED] a story of GONCALVES going outside to take Murphy (GONCALVES dog), to urinate. There was a man watching her, from the dumpster near the house. GONCALVES called [REDACTED] to see when she was going to be home. She did not know a timeline of when this event took place, or what time of day this took place.

17. The weekend prior to the homicides, MOGEN had flown down to Boise and [REDACTED] and MOGEN spent time together. MOGEN never mentioned anything about this

18. She was told (she believed by GONCALVES sister), [REDACTED] (GONCALVES [REDACTED]) woke up the morning after the homicides with 16 missed calls from GONCALVES and MOGEN, which occurred at approximately 3:00 AM. GONCALVES had called approximately 10 times, and MOGEN had called approximately 6 times. There were also text messages sent to [REDACTED] saying things like, "Bro, what the fuck? Wake up." GONCALVES was known for calling a lot of times consecutively when she wanted to contact someone. Neither GONCALVES nor MOGEN would call [REDACTED] instead of the police for help. [REDACTED] and GONCALVES had dated previously. They were currently broken up, but good friends, and [REDACTED].

19. She is frustrated by the rumors and random accusations on social media.

20. The interview ended at approximately 1:27 PM. For complete details review audio recording of the interview. The audio recording was copied onto a flash drive and submitted into evidence under Tag# 220004205, item 1.
