I was unable to preserve the footage directly from the application, so I made several screen recordings as the footage played on my phone. camera is motion activated and records audio. Notably, Goncalves and Mogen walk past the camera with at 01:40:50 hours on 11/13/2022.

3. The video recordings and screen shots I captured of individuals passing the camera were provided to the Moscow Police Department group reviewing the video footage of the area.
