**Narrative**

- On November 17th, 2022, at approximately 1:02 P.M., Idaho State Police Detective Lieutenant Catlin and I conducted an interview with [REDACTED]. The interview was in reference to the murder of Madison Mogen, Kaylee Goncalves, Xana Kernodle and Ethan Chapin, which occurred at 1122 King Road, Moscow, Idaho, on November 13th, 2022. The interview took place in front of [REDACTED] residence, located at [REDACTED], Boise, Idaho.
- [REDACTED] reported the following during the interview:
- On November 12th, 2022, he woke up stated watching college football and then went to the gym.
- His roommate [REDACTED] had a dart tournament at "Moose Lounge" (Moose Lodge) which is next door to the Corner Club. At approximately 5:00 P.M. or 6:00 P.M., he went to the Moose Lodge and started drinking. Moose Lodge had a Veterans special. They were at Moose Lodge until approximately 9:00 P.M., and then they went to Mingles Bar and Grill for about an hour. After Mingles, they went to the Corner Club but at this point in the evening, he was intoxicated. He did not remember getting kicked out of the Corner Club and did not know why he was kicked out.
- At approximately 11:21 P.M., he and Madison Mogen took a picture together while they were at the Corner Club. Mogen sent it in a group text to [REDACTED]. Also sent with the photo was a text message saying, "get to the club [REDACTED]". He didn't remember taking the photo with Mogen and didn't remember who Mogen was with. This was also the first time he'd seen Mogen outside of class and school projects.
- He didn't remember much from the evening but said he walked home from the Corner Club. His address was [REDACTED], Moscow, Idaho.
- His roommate, [REDACTED] got home around 1:30 A.M. to 1:40 A.M. His other roommate, [REDACTED] told him he got home about thirty minutes before [REDACTED] (approximately 1:00 A.M) and that was the end of the night for him. His roommates are [REDACTED] and [REDACTED] were a couple.
- On November 13th, 2022, he woke up at approximately 12:00 P.M.
- He learned of the incident through a "Vandal Alert" (student email) that afternoon which explained the situation. An hour after receiving the first "Vandal Alert" he received another which told him there was no suspect and to remain vigilant. A third "Vandal Alert" was sent out that evening while he was at work which had details of how many victims there were.
- He didn't know Mogen was one of the victims until Monday afternoon when he received an email from his

professor of Marketing [REDACTED] He, Mogen, and [REDACTED] are in marketing [REDACTED] at the University and worked together on group projects. They were working on a project for [REDACTED] which was a café in town Mogen worked for. When they worked on projects together, they would meet and work in basement of the Albertsons building on campus. He hadn't ever been to Mogen's house and didn't know until recently where she lived.

11. He worked at [REDACTED] in Moscow and has worked for [REDACTED] for eight years in total. As he transferred colleges, he moved stores with [REDACTED] His boss said the store carried old Ka-Bar knives, but they were an older clearance item. He didn't know what kind of sheath a Ka-Bar knife would come with.

12. He didn't know Kaylee Goncalves and didn't remember seeing her at the Corner Club. He didn't know any of the victims besides Mogen.

13. Mogen was the only person from the house he spoke with, and it was mainly related to class projects. He'd only talked to Mogen approximately four or five times throughout the school year. They mainly used text messaging to communicate. He read us the group text he, Mogen, and [REDACTED] used. The last text from Mogen was the photo and text message at the Corner Club. [REDACTED] responded the following day which was the last text in the thread.

14. He was attending his last semester at the university, and he thought Mogen was going to finish in 2023.

15. He started college at Treasure Valley Community College, transferred to Utah Tech University, and from 2017 to 2019 he started attending the University of Idaho. In 2019 he joined the Army Reserve as a culinary specialist. After two years he went back to the University of Idaho to finish his schooling.

16. He never heard of any issues Mogen had with anyone. He did not know if Mogen used any narcotics. They never spoke of anything personal.

17. He didn't have a car and walked wherever he needed to go around the campus. He road the bus home to Boise and barrowed his brother's pickup while he was in town.

18. [REDACTED] did not have any injuries to his hands, arms, or face.

19. At approximately 1:36 P.M. [REDACTED] consented to a DNA sample. Idaho State Police Detective Millar arrived on scene and collected a DNA sample from [REDACTED] which I took custody of and submitted it into evidence for processing.

20. At approximately 1:38 P.M., we concluded the interview.
