**Narrative**

1. On November 18th, 2022, at approximately 1:34 P.M., Idaho State Police Detective Pesina and I conducted an interview with [REDACTED] [REDACTED]. The interview was in reference to the murder of Madison Mogen, Kaylee Goncalves, Xana Kernodle and Ethan Chapin, which occurred at 1122 King Road, Moscow, Idaho, on November 13th, 2022. The interview took place at the Idaho State Police District 3 Office, located at 700 S. Stratford Drive, Meridian, Idaho.
2. [REDACTED] reported the following during the interview:
3. He lived at [REDACTED], Moscow, Idaho, while attending the University of Idaho. His house was near where the homicide occurred. He also lived at [REDACTED], Star, Idaho, when he was not at the university.
4. His roommates in Moscow are [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED] [REDACTED] [REDACTED] and [REDACTED] lived upstairs. His house was all older members of the [REDACTED] fraternity.
5. He only knew Kaylee Goncalves because [REDACTED] dated her. He met Goncalves his freshman year when [REDACTED] started dating her.
6. [REDACTED] and Goncalves relationship was good, he never saw them fight or have a disagreement. [REDACTED] never talked about his relationship with Goncalves to him. He did know [REDACTED] and Goncalves had broken up because Goncalves got a job offer in Texas.
7. He didn't hear until recently one of the girls had a stalker outside of WinCo. He heard this from [REDACTED] [REDACTED]
8. He did not know if the victims' used drugs.
9. On November 12th, 2022, it was game day for the University of Idaho. He wasn't sure when he woke up but thought it was around 9:00 A.M. or 10:00 A.M. He got some beer and went upstairs to his house and started drinking.
10. He went to the Kibbie Dome parking lot for the tailgate before the football game, and was there for an hour or two before the game started. He went into the game and left the game about five minutes to the end because the University of Idaho was losing.
11. He got a ride from the football game back to his house from his "sober buddy" (sober person from his fraternity designated to drive). At his house he drank some more and watched the UFC fights. After the fights, he went to the Corner Club. Everyone he lived with was at the Corner Club. He only saw Goncalves at the Corner Club. [REDACTED] [REDACTED] told him Madison Mogen there as well.
12. At approximately 1:30 A.M. he called his "Sober buddy" to pick him up. His "Sober buddy" got pulled over and he didn't want to pile everyone in one car in front of the cops, so he called another "Sober buddy" to pick him up. He, [REDACTED] and [REDACTED] got a ride home from the second "Sober Buddy". They got home around 1:45 A.M.
13. He made some pizza rolls and went to bed about fifteen minutes after getting home.
14. He was intoxicated for a majority of the day and did not remember specific details.
15. He did not have any injuries to his hands, arms, or face.
16. At approximately 1:49 P.M., we concluded the interview.
