Summary Narrative

On November 19, 2022, at approximately 1501 hours, I, Idaho State Police Trooper Kristen Noah, assisted detectives with homicide investigation that occurred on 1122 King Road, Moscow, Latah County, Idaho by canvassing the neighborhood area for security cameras on Conestoga Street, Cayuse Drive, Pinto Drive, Colt Road, and Appaloosa Road.

Narrative

1. On November 19, 2022, at approximately 1501 hours, Idaho State Police Detective Leslie Lehman and myself, Idaho State Police Trooper Kristen Noah, were requested to canvas the neighborhood area for security cameras on Conestoga Street, Cayuse Drive, Pinto Drive, Colt Road, and Appaloosa Road.

2. Detective Lehman and I started canvassing the neighborhood at the junction of Conestoga Street and Appaloosa Road. We started at residential address [REDACTED] and walked southbound on Conestoga Road to the intersection of Colt Road. We ended at residential addresses [REDACTED] Conestoga.

3. We walked westbound on Colt Road to the intersection of Pinto Drive. We walked northbound on Pinto Drive to the intersection of Cayuse Drive. We walked eastbound on Cayuse drive to the intersection of Conestoga. We went back to the intersection of Colt Road and started eastbound on Colt Road to the intersection of Appaloosa Road. We walked northbound on Appaloosa Road, covering the two residential addresses on Fort Stevens Street, and ended at residential addresses [REDACTED], which was near the starting intersection of Appaloosa Road and Conestoga.
