Narrative

1. On November 18, 2022, at approximately 5:24 PM, Homeland Security Investigations Task Force Officer (TFO) Sage Collins and I, Idaho State Police Detective Matt Wernsing, interviewed [REDACTED] (DOB [REDACTED]/2000) in regard to the homicide of Kaylee GONCALVES, Madison MOGEN, Xana KERNODLE, and Ethan CHAPIN. The interview took place at [REDACTED] in Caldwell, Canyon County, Idaho. The following is summary of [REDACTED] statement:
2. [REDACTED] knew GONCALVES and MOGEN fairly well through school and Greek life.
3. [REDACTED] went to the Corner Club at approximately 9:00 PM on Saturday, November 12 where he hung out with a group of friends for a few hours. He listed [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] GONCALVES, and MOGEN. GONCALVES and MOGEN left the Corner Club approximately an hour before [REDACTED] left. [REDACTED] left with [REDACTED] and [REDACTED] at approximately 2 AM and went to [REDACTED] and [REDACTED] house on King St. [REDACTED] stayed the night at their house.
4. [REDACTED] did not notice anything suspicious. He went to sleep around 3:00 AM and woke up around 11:00 AM.
5. While at the Corner Club, there was a male subject with shorter hair, wearing a dark shirt and U of I cap, and later put on a white and black plaid flannel. He was being excessive and was paying a lot of attention to [REDACTED] but not necessarily to GONCALVES or MOGEN. [REDACTED] roommate, [REDACTED] [REDACTED] was [REDACTED] [REDACTED] that night and kicked the male subject out.
6. [REDACTED] was unsure of who else was [REDACTED] that night. He said [REDACTED] [REDACTED] and [REDACTED] [REDACTED] also [REDACTED], and were most likely working on a game night.
7. [REDACTED] was [REDACTED] [REDACTED] roommate for one semester at one point.
8. [REDACTED] had heard one of the roommates, [REDACTED] had a stalker, but did not believe GONCALVES or MOGEN had a stalker.
9. [REDACTED] mentioned an Uber Driver named [REDACTED] [REDACTED] is known to give the sorority girls rides home from the bars, [REDACTED] girls in particular. The girls contact [REDACTED] on his personal phone and pay him through Venmo and not through the Uber app. [REDACTED] had given [REDACTED] [REDACTED] and [REDACTED] a ride that night and [REDACTED] paid through Venmo.
10. The interview was concluded at 5:41 PM. For complete details from [REDACTED] statement, review notes and audio recording of interview.
11. I transferred the audio recording of the interview to a CD and submitted it into ISP Evidence under Tag #220004290.
