GONCALVES and MOGEN left the Corner Club approximately an hour before left. left with and at approximately 2 AM and went to and house on King St. stayed the night at their house.

5. While at the Corner Club, there was a male subject with shorter hair, wearing a dark shirt and U of I cap, and later put on a white and black plaid flannel. 9. mentioned an Uber Driver named is sknown to give the sorority girls rides home from the bars, girls in particular. The girls contact on his personal phone and pay him through Venmo and not through the Uber app. had given paid through Venmo.
