## Narrative

1. On November 18, 2022, at approximately 1806 hours, I, Idaho State Police (ISP) Detective Brady Walker, interviewed [REDACTED] by phone at [REDACTED]. ISP Trooper Kristin Noah was present during the phone call. The phone call was recorded. This report details the phone interview with [REDACTED]. This report also contains summaries from interviews with [REDACTED] and [REDACTED] who were with [REDACTED] on the night of 11/12/2022. Those summaries are also documented in Supplement 52.
2. It was reported to me that [REDACTED] had text conversations with Ethan Chapin the night of the incident, but [REDACTED] denied that. [REDACTED] had been in the [REDACTED] as Chapin for a year and a half and described Chapin as one of his best friends. [REDACTED] lived in an apartment at [REDACTED]. His roommates are [REDACTED] and [REDACTED] (unknown number).
3. [REDACTED] was present with Chapin in the lodge at [REDACTED] but they didn't really have much contact. [REDACTED] specifically said he was "off doing his own thing" and hanging out with his girlfriend. When I asked who his girlfriend was, [REDACTED] paused, and said, "Um, I don't really feel comfortable answering these questions. I don't know." I asked [REDACTED] if there was any reason why. He replied, "I, I just, I don't know, like out of respect of Ethan. I don't know, like, ok, [REDACTED] is my girlfriend. I'll just answer the questions." After that, [REDACTED] seemed more forthcoming with information.
4. [REDACTED] and [REDACTED] were at [REDACTED] most of the night. [REDACTED] went to bed early, and then he went to the [REDACTED] apartments. He went there with [REDACTED] and [REDACTED] who were a couple of his fraternity brothers, around 0130 on the morning of 11/13/2022. They went to the upper right apartment. [REDACTED] believed it was number [REDACTED] and it was commonly called [REDACTED] by everyone. There was a male resident there named [REDACTED] (unknown last), along with [REDACTED] and a couple of unidentified females. They stayed there for a couple hours before leaving around 0330, returning to [REDACTED]. When they left the [REDACTED] they went down the stairs, across the parking lot, crossed Taylor Avenue, and went across the field to [REDACTED]. [REDACTED] made some food and went to bed around 0500 hours.
5. [REDACTED] said he did not text or have any other electronic communication with Chapin that night. He did not know when Chapin left the [REDACTED] party.
6. [REDACTED] knew Chapin and Kernodle had been dating since before the previous school year ended. He estimated it was about seven months. Chapin stayed with Kernodle about six days per week. [REDACTED] said he knew Kernodle fairly well, but did not know Goncalves or Mogen as well. [REDACTED] would see Goncalves and Mogen "here and there", but they would not sit down and have a conversation or spend time together.
7. [REDACTED] went to 1122 King Road once every week or two weeks. He said a party was hosted there about weekly. A typical party would be attended by fifty or sixty people. He described the dynamic of the house as "fine" and stated they all seemed to get along really well.
8. [REDACTED] knew [REDACTED] for about a year and a half and knew her fairly well. [REDACTED] did not have a boyfriend and had lived at 1122 King Road since the start of that semester. [REDACTED] had just met [REDACTED] at the beginning of the semester and knew her from going to 1122 King Road to hang out. [REDACTED] did not have a boyfriend that [REDACTED] was aware of.

9. [REDACTED] could not think of any person who would do something like this.
10. I am also including the interview summaries of [REDACTED] [REDACTED] and [REDACTED] [REDACTED] who were with [REDACTED] the night of the incident, with this report is due to their proximity to 1122 King Road.
11. I tried to contact [REDACTED] (DOB [REDACTED]/2003) on 11/19/2022 at about 1816 hours at [REDACTED] [REDACTED] did not answer but called me back at about 1829 hours. [REDACTED] was roommates with Ethan Chapin last year and was currently a roommate of [REDACTED] [REDACTED]. He had daily contact with Chapin, who would commonly come over to play Xbox with [REDACTED] [REDACTED] was one of Chapin's best friends. [REDACTED] had known Kernodle since before she and Chapin started dating. [REDACTED] didn't really know Goncalves or Mogen. [REDACTED] identified his girlfriend as [REDACTED], and he provided a phone number of [REDACTED]. [REDACTED] had gone to 1122 King Road a few times this year. On November 12th, [REDACTED] attended the Formal party and went to the [REDACTED] party afterwards. He left the [REDACTED] party around 0100 and went to a party at the [REDACTED] apartment building accompanied by [REDACTED] and [REDACTED]. The apartment unit they went to was referred to as [REDACTED]. They were at the [REDACTED] until about 0500 hours when they returned to their unit at [REDACTED]. They went to bed around 0530. [REDACTED] had no contact with Chapin since the Formal and did not have any contact with Kernodle that day.
12. I tried to contact [REDACTED] (DOB [REDACTED]/2004) on 11/19/2022 at 1850 hours at [REDACTED] but he did not answer. [REDACTED] called me back on 11/25/2022 at 1013 hours. [REDACTED] is a roommate of [REDACTED] [REDACTED] was friends with Chapin and saw him daily. Chapin's best friend in their [REDACTED] fraternity was [REDACTED]. Chapin would come to the fraternity house and play Xbox with [REDACTED] almost daily before class. [REDACTED] had only been to 1122 King Road a couple of times. [REDACTED] had gone to the Formal event on the night of 11/12/2022. [REDACTED] left the Formal event and got back to [REDACTED] around 2030/2045 p.m., where there was an after-party event. The party took place in a common room. He spoke with Chapin once at the after-party. [REDACTED] left [REDACTED] around 0115 hours on 11/13/2022. He went to a party at the [REDACTED] top right apartment with [REDACTED] and [REDACTED]. There were at least two males at the apartment, and [REDACTED] believed their names were [REDACTED] and [REDACTED]. They stayed there until about 0330/0400 hours, when they went back to [REDACTED]. They all went to bed around 0415. [REDACTED] said his timelines towards the end of the night were estimates due to his consumption of alcohol.
