- a. On 11/16/2022 at 1808 hours, Idaho State Police (ISP) Detectives Cody Herman and Andy hold called [REDACTED] (DOB: [REDACTED] 1993). The phone call is recorded (Herman recorder A1). The following is a summary of the conversation.
- b. [REDACTED] claimed his second cousin, [REDACTED] [REDACTED] may know the female victims. [REDACTED] believed [REDACTED] had attended University of Idaho as a student during the same time as the victims. [REDACTED] has not spoken with [REDACTED] for approximately 10 years and did not have [REDACTED] phone number.
- c. [REDACTED] believes [REDACTED] may know the victims because he spoke to [REDACTED] mother [REDACTED] via Facebook recently and [REDACTED] made mention that [REDACTED] may know the victims. [REDACTED] stated [REDACTED] was "rushing" sorority's and that is why she may know the victims. [REDACTED] does not have [REDACTED] phone number and only has contact with her through Facebook. [REDACTED] did not have any suspicions or details of the crime to report.
- d. [REDACTED] was given Detective Hodl's phone number and asked to try to get [REDACTED] or [REDACTED] phone numbers. [REDACTED] [REDACTED] name is not listed on any of the provided sorority's roster.
- e. No further information is available at this time.

## Narrative

- a. On 11/17/2022 at approximately 1218 hours, ISP Detective Cody Herman contacted [REDACTED] via a recorded phone call (Herman recorder A3) regarding a phone Tip #0031.
- b. [REDACTED] would be accurately described as a [REDACTED] who has no relation to any of the victims. [REDACTED] lives in Virginia and has never been to Idaho. [REDACTED] started looking at the victim's social media accounts for suspicious activity after seeing the news coverage of the crimes.
- c. [REDACTED] reported Kaylee Goncalves has an Instagram account. Kaylee had posted a picture of herself in a bikini approximately three years ago on her Instagram account and [REDACTED] believed a male named [REDACTED] left a suspicious comment on the picture. The comment stated, [REDACTED] This comment was posted approximately 172 weeks ago according to Instagram.
- d. [REDACTED] Instagram handle is reported to be [REDACTED] [REDACTED] has a Facebook account with a background photo of [REDACTED].
- e. According to [REDACTED] [REDACTED] may have gone to the same [REDACTED] as Kaylee Goncalves and may be [REDACTED] than Kaylee Goncalves.
- f. [REDACTED] said [REDACTED] social media accounts appear to show him as an avid hunter and fisher. [REDACTED] stated [REDACTED] would be very familiar with the use of knives because he is a hunter and fisher. [REDACTED] made comments stating his concerns about how awkward it would have been for Kaylee to go to [REDACTED] as [REDACTED] after that comment.
- g. [REDACTED] stated it did not appear [REDACTED] and Kaylee were very good friends because of a lack of comments on each other's social media accounts.
- h. [REDACTED] was provided Detective Herman's phone number for any future contact.
- i. No further information is available at this time.

- a. Detective Cody Herman and Andy Hodl contacted [REDACTED] [REDACTED] via recorded phone call (Herman recorder A4). [REDACTED] reported throwing her garbage away in the dumpster in front of her four plex residence on 11/17/2022 at approximately 1430 hours. While throwing her garbage away, she noticed a gray colored smart phone with no cover in the dumpster.
- b. [REDACTED] stated the dumpster usually gets picked up Thursday mornings around 0700 a.m. [REDACTED] stated the garbage was picked up this morning and there was not a lot of garbage in the dumpster. [REDACTED] lives at [REDACTED] in Moscow, Idaho. This residence is a couple miles away from the King Street scene.
- c. Detective Herman contacted ISP Sergeant Justin Klitch and requested retrieval of the phone. Sergeant Klitch retrieved the phone at approximately 1420 hours and brought it to Detective Herman.
- d. The phone is a silver Samsung Galaxy S8 IMEI# 358331081430605. Detective Herman transferred the phone to Moscow Police Detective Laurence Mowery.
- e. No further information is available at this time.

- a. On 11/17/2022 ISP Sergeant Curt Sproat contacted [REDACTED] at a University of Idaho volleyball game due to suspicious behavior. During that interaction [REDACTED] requested representation. [REDACTED] was released and he agreed to come back to on 11/18/2022. Refer to ISP Case #L22001014 for details.
- b. On 11/18/2022 at approximately 1005 hours, Sergeant Sproat made a recorded call to [REDACTED] at [REDACTED] [REDACTED] answered and agreed to come into Moscow Police Department for an interview. [REDACTED] advised he was unable to find a lawyer, but he ultimately decided he did not need one. (Herman recorder B1).

### Narrative

- c. At approximately 1025 hours, [REDACTED] arrived at Moscow Police Department and was interviewed by Detective Herman and Sergeant Sproat. (Herman recorder B2). During the interview [REDACTED] explained how he was nervous because of the heavy police presence, and he made a mistake by running from the police.
- d. [REDACTED] stated he currently lives at the [REDACTED] [REDACTED] alone. [REDACTED] is currently going to the University of Idaho for [REDACTED] and is in [REDACTED] [REDACTED] currently. [REDACTED] claimed to own a [REDACTED] [REDACTED] that has faded silver paint. The following is the timeline [REDACTED] provided as an alibi during the time of the homicides.
- e. At approximately 2:30 p.m. on Saturday 11/12/2022, [REDACTED] went hiking on Moscow Mountain with two friends named [REDACTED] [REDACTED] (unknown spelling for [REDACTED] and [REDACTED] [REDACTED] until approximately 6:45 p.m.
- f. [REDACTED] and [REDACTED] both attend Washington State University (WSU) for [REDACTED] [REDACTED] [REDACTED] became friends with [REDACTED] and [REDACTED] after meeting them at a WSU sporting event.
- g. At approximately 7:00 p.m. [REDACTED] [REDACTED] and [REDACTED] ate dinner at "The Eatery" on campus. At approximately 7:45 they finished dinner and [REDACTED] was given a ride to the movie theatre in Pullman, Washington.
- h. [REDACTED] [REDACTED] and [REDACTED] and [REDACTED] [REDACTED], [REDACTED] [REDACTED] watched the movie "Wakonda" with a start time of 8:15 p.m.

Detective Herman asked [REDACTED] if he was willing to meet with Detectives in Coeur d'Alene and provide a voluntary DNA sample. [REDACTED] agreed. Detective Snell agreed to meet with [REDACTED] On 12/07/2022 Detective Snell contacted Detective Herman and advised that [REDACTED] met with him and ISP Detective Leslie Lehman.
