2. Upon arrival [REDACTED] was [REDACTED] with Sergeant Stennett and I. Upon explaining why we were there, [REDACTED] began speaking prior to being able to activate the audio recording device. [REDACTED] explained her [REDACTED] [REDACTED] made statements to her that X. Kernodle's death better not be due [REDACTED].
3. [REDACTED] last spoke with X. Kernodle about a month prior to the homicide when she attempted to coordinate having lunch with X. Kernodle. [REDACTED] said X. Kernodle ended up being too busy with classes and was not able to meet.
4. [REDACTED] said she was unaware of anyone who would want to hurt X. Kernodle. [REDACTED] said [REDACTED] questioned her inquiring if she had any [REDACTED] and if X. Kernodle could have been killed as [REDACTED]. [REDACTED] told us she has never been involved [REDACTED]. [REDACTED] said [REDACTED] hated X. Kernodle and stated we should look at her.
