Narrative

- On November 18, 2022, Idaho State Police Detective Sergeant Hoxie and I, Detective Pesina, interviewed University of Idaho student [REDACTED] (D.O.B. [REDACTED]/2001).
- I asked [REDACTED] to run me through his day. [REDACTED] stated the following:
- [REDACTED] said he started his day at approximately 10:30 to 11:00 A.M. Got some food and ate. He took his girlfriend [REDACTED], some beer at "treehouse". They started drinking prior to the Vandal game.

Narrative

4. At approximately 4:00 P.M., [REDACTED] said he went to the game. [REDACTED] returned home between 8:00 to 9:00 P.M. and had a sandwich. [REDACTED] said he took a two hour nap.
5. At approximately 11:00 P.M., [REDACTED] woke up, his roommate was wanting to go to the bar. They went to the Corner Club, had a few beers and hung out.
6. At approximately 1:45 A.M., their fraternity president, [REDACTED] [REDACTED] picked up [REDACTED] [REDACTED] [REDACTED] and [REDACTED] and drove them home.
7. After getting home, they hung out for about 15-20 minutes to check on his friend who had consumed too much alcohol.
8. [REDACTED] said he went to his room where his girlfriend was already in bed. [REDACTED] said they talked for a bit and believed he fell asleep around 2:45 A.M.
9. I asked [REDACTED] if he heard any noises that could have woken him. [REDACTED] said no. He did say his friend [REDACTED] [REDACTED] told him he heard a dog barking between the hours of 4:15 A.M. and 5:00 A.M. [REDACTED] said it sounded like Murphy. Murphy was a dog who was shared between their two houses. [REDACTED] said Murphy was at the girl's house that day.
10. I asked [REDACTED] how close he knew the girls. He said, "I'm like a handshake to them". [REDACTED] knew Kaylee Goncalves through [REDACTED] they had dated for a while. He never really talked to Madison Mogen. He was friends with Xana Kernodle and had met Ethan Chapin at an event called Rush.
11. I asked [REDACTED] if he had seen any of the victims that night. [REDACTED] said he saw Goncalves and Mogen at the Corner Club. [REDACTED] said they were with [REDACTED] [REDACTED]. He said they were heading to Johns Alley. [REDACTED] said he heard [REDACTED] was kicked out of Johns Alley. After Johns Alley the three of them went to Grub Truck and he believed they went home afterwards.
12. I asked [REDACTED] if any of the victims were involved in the use of drugs. He said he knew [REDACTED] [REDACTED] and Goncalves and Mogen had [REDACTED]. He wasn't sure if Kernodle [REDACTED].
13. Sgt. Hoxie asked if the girls had a party the night before or the day of the incident. [REDACTED] said he saw a bunch of people dressed up and walking up to the house with speakers. He believed they had a "formal" the night before the incident.
14. Sgt. Hoxie asked if he had heard about a stalker. [REDACTED] said he had heard from [REDACTED] [REDACTED] Sunday night, Goncalves was followed to her car in the parking lot at WinCo. He heard Goncalves might have been followed in the store as well.
15. Sgt. Hoxie asked [REDACTED] how he heard about the incident. [REDACTED] said [REDACTED] [REDACTED] best friend, facetimed her and said, "hey there's a bunch of police officers outside, do you know what's going on?" [REDACTED] went upstairs and saw the officers taping off the scene.
16. [REDACTED] said after the WinCo thing happened, [REDACTED] [REDACTED] told him a couple weeks ago, all the roommates were out of the house getting groceries. When they returned, their sliding glass door was open.
17. I asked [REDACTED] if there was any other information he feels we should know. [REDACTED] said he had heard from [REDACTED] that one of the girls was downstairs. When she opened the door, she saw a person in a ski mask, made eye contact, slammed her door and locked it.
18. Interview was terminated.
