### Summary Narrative

On November 13, 2022, at about 12:22 p.m., the Moscow Police Department (MPD) requested Idaho State Police (ISP) District 2 (D2) Investigations to assist with multiple homicides at 1122 King Rd., Moscow, Latah County, Idaho. The victims were identified as Kaylee Goncalves (GONCALVES), Madison Mogen (MOGEN), Xana Kernodle (KERNODLE), and Ethan Chapin (CHAPIN).

I, ISP Detective (Det.) Jeffory R. Talbott was assigned as the lead crime scene investigator. On November 17 and 18, 2022, the ISP Forensics Services (ISPFs) personnel returned to the scene for further processing and evidence collection. All items collected were turned over to MPD.

**Narrative**

1. On November 17 and 18, 2022, ISP Forensic Scientist (FS) Jennie Ayers, FS Kerry Hogan, FS Tara Martinez, and FS Wyatt Barie responded to 1122 King Rd., Moscow, Latah County, Idaho for further processing of the residence.

2. The ISPFs processed the residence and the following items were seized:  
(Refer to the forensic report for full details of the processing)

- A. Exhibit 061: Potential hair, collected from north wall of floor 2 hallway.
- B. Exhibit 062: Potential hair, collected from south wall of floor 2 hallway.
- C. Exhibit 063: Cigarette butt, collected from yard, south side of house behind sofa.
- D. Exhibit 064: Note, collected from parking lot on north side of house, east of Ford SUV.
- E. Exhibit 065: Potential hair, collected from south side of half wayll, floor 2.
- F. Exhibit 066: Potential hair, collected from floor 2, west bedroom.
- G. Exhibit 067: DNA swab, collected from exterior of south kitchen window.
- H. Exhibit 068: DNA swab, collected from exterior of south kitchen window.
- I. Exhibit 069: DNA swab, collected from exterior of south kitchen window.
- J. Exhibit 070: Router and Modem, located in alcove, north wall of living room.
- K. Exhibit 071: 21 blood swabs, refer to forensic report for locations.
- L. Exhibit 072: 6 Latent lift cards, collected from exterior of south kitchen window.

3. After ISPFs processed the residence, all items collected were turned over to me. ISPFs resealed windows and doors that were opened during processing and left the scene. I resealed the front door and transported the evidence to the ISP District 2 office and placed them into a secured temporary evidence locker.

4. Law enforcement remained on the scene outside the residence.

5. On November 19, 2022, ISPFs provided me with a copy of the photographs and video taken. I transported the
