3. Narrative

On 11/16/22, I spoke with K [REDACTED] N [REDACTED] at the sub station on the University of Idaho (UI) campus. I asked K [REDACTED] if she had any special relationships with any of the victims and K [REDACTED] said she was really good friends with Xana Kernodle and met Xana freshman year. K [REDACTED] said she was also close friends with Kaylee Goncalves and met her freshman year during recruitment. K [REDACTED] said she knew Kaylee the best.

I asked K [REDACTED] if Kaylee hung out or associated with anyone with violent tendencies. K [REDACTED] said no, and expressed she was confused about the incident because what she saw on the news. K [REDACTED] said Kaylee mainly stuck together with her roommates (Xana, B [REDACTED] F [REDACTED], Madison Mogen, D [REDACTED] M [REDACTED]).

K [REDACTED] said that Kaylee also hung out with the "King Girls" which were J [REDACTED] T [REDACTED], N [REDACTED] F [REDACTED], E [REDACTED] D [REDACTED], and A [REDACTED] V [REDACTED]. I asked K [REDACTED] if Kaylee was involved in using illegal substances and K [REDACTED] said "just coke probably." I asked K [REDACTED] if she saw Kaylee doing cocaine and K [REDACTED] said no, but she knew Xana was pretty into it.

Det. Deane asked if Ethan Chapin (Xana's boyfriend) was into cocaine and K [REDACTED] said she did not know. K [REDACTED] said she didn't know Ethan that well. Det. Deane asked if drugs were being sold from the house or if the drugs were more used for parties. K [REDACTED] said they were used but not sold. Det. Deane asked if there were large quantities of drugs at the house or if the house was known as a drug house and K [REDACTED] said no.

I asked K [redacted] if Kaylee ever mentioned about having a stalker or having concerns about anyone and K [redacted] said no. K [redacted] also said Kaylee never mentioned anything to the girls. K [redacted] asked if we saw the Twitch stream. I asked K [redacted] what she saw in the stream and she mentioned there were two guys. I asked K [redacted] if she recognized the two guys and K [redacted] said she did not. K [redacted] said her friend E [redacted] and "G [redacted]" were at the Grubtruck and saw Kaylee and Madison. K [redacted] said E [redacted] mentioned that the two males were being weird. I asked K [redacted] if she or anyone recognized anyone from the Grubtruck stream and K [redacted] said no. I asked K [redacted] if she was familiar with the fraternity members of [redacted] and she said yes.

I asked K [redacted] if there was anything mentioned why the males were labeled as weird. K [redacted] said she thought one of the males nudged the other male like "oh those are your girls go and get them." K [redacted] said that E [redacted] would be worth talking to because she was there during that time. I asked K [redacted] if E [redacted] spoke with Kaylee and K [redacted] said she might have said hi but wasn't sure. K [redacted] also mentioned that Z [redacted] M [redacted] hung out with Kaylee and Madison all night at the Corner Club.

I asked K [redacted] if any of the victims had any issues with anyone and K [redacted] said that Kaylee was un-problematic and peaceful. K [redacted] said she cant imagine someone with violent tendencies around her. K [redacted] said she felt the same way about Madison. K [redacted] said if anything maybe Ethan and Xana. I asked if Ethan and Xana associated with violent people. K [redacted] said this because K [redacted] said that Xana and Ethan were more outgoing and hung out with different friend groups.

Det. Deane asked if Kaylee or Madison recently had a boyfriend or ex-boyfriend. K [redacted] said Kaylee dated a guy named "J [redacted]" (J [redacted] D [redacted]) for a couple years and Kaylee and J [redacted] were high school sweethearts. K [redacted] said J [redacted] was a really nice person. K [redacted] said she spoke to Kaylee a couple days before the incident and Kaylee said once she graduated, she was looking for a apartment in Texas. K [redacted] said Kaylee met a guy from Texas that is already living in Texas and they were going to be roommates. I asked K [redacted] if Kaylee and J [redacted] were still together when Kaylee mentioned that to her and K [redacted] said no that they were already broken up.

K [redacted] said that J [redacted] mentioned that Kaylee attempted to call J [redacted] around 0300 hours asking if he was up. K [redacted] said she didn't think that J [redacted] replied to Kaylee because he thought it was some type of "booty call." Det. Deane asked how they knew that Kaylee attempted to reach out to J [redacted] and K [redacted] said because J [redacted] told them. K [redacted] said she thought they found out after people were asking J [redacted] if he knew anything about what happened.

Det. Deane asked if Madison had a boyfriend, and K [redacted] said yes, and they call him "S [redacted]" and said she thought his first name was J [redacted]. K [redacted] said they are still together. K [redacted] said she does not think they had problems and S [redacted] was a good guy. Det. Deane asked what he looked like and K [redacted] said S [redacted] was short, maybe 5'7", and balding. K [redacted] said he had brown hair and was skinny. K [redacted] thought he lived in Coeur d'Alene.

K [redacted] said E [redacted] was Madison's "little." K [redacted] said Kaylee and Madison were the closest out of all the roommates. Det. Deane asked if D [redacted] had a boyfriend. K [redacted] said yes. K [redacted] said his name is Q [redacted] K [redacted] and lived in Boise. K [redacted] said that Q [redacted] was nice and hardworking. K [redacted] said Q [redacted] had epilepsy and was not a violent person.

K [redacted] said she was not aware of any issues between roommates. I asked if Kaylee

hung out with any other males. K████ said Kaylee was talking to a guy named M████ B████ who was a member of █████. K████ said they had a sexual relationship and would "hook up" here and there. K████ described M████ to be over six feet, brunette, and medium build. K████ said he was serving as vice president to █████.

I asked K████ if there was anyone else Kaylee spent time with and K████ said no unless Kaylee met someone at the bar that night. K████ did not know if Kaylee met anyone in particular, but heard a male got kicked out for being creepy towards Madison. K████ said J████ or Z████ could probably have more info because they were also at the bar.

K████ said the last time she spoke to Kaylee was at about 1700 hours on 11/13/22. K████ said Kaylee showed up with all of Kaylee's roommates at her apartment "The Whites" sometime between 1430-1500 hours. K████ said they left sometime between 1700-1800 hours. I told K████ I was aware of a social media post of all the roommates pictured together and K████ said that was at her apartment. I asked K████ if she has been over to Kaylee's house before. I asked if people usually the wifi and K████ was unsure. K████ said they usually leave their doors unlocked and everyone knows it's a █████ out of house. I asked why Kaylee lived in a house with a different sorority and K████ said that Kaylee and Madison have been best friends for several years and spoke about living with each other. K████ said that Kaylee was still close with her freshman/sophomore friend group.

I asked K████ if she was aware of any cameras in the area and K████ said no. Det. Deane asked K████ if she saw anyone in the area that seemed out of pace and K████ said she thought while she was at her apartment, and does not remember who, but said somebody mentioned about a random kid carrying a bb gun but no one thought anything of it.

K████ said she has reached out to E████ on 11/13/22 after the incident but she did not reply. K████ said maybe E████ A████ has reached out but was unsure. I asked if anyone has reached out to L████ or B████ and K████ said maybe E████ A████.

I concluded my interview.
