Narrative

1. On November 18, 2022, I, Idaho State Police (ISP) Detective Leslie Lehman along with ISP Detective Jacob Schwেকে interviewed [REDACTED] (DOB [REDACTED] 1996) at his apartment at [REDACTED], Moscow, Idaho. 2. At 1240 hours, I located [REDACTED] at his apartment and he agreed to come out and speak to me. The interview was not audio recorded.

3. [REDACTED] said he was at work at [REDACTED] until 2330 hours on 11/12/2022. [REDACTED] met with his girlfriend, [REDACTED] at John's Alley Bar. [REDACTED] was unsure of times in the early morning hours after leaving the bar but confirmed a Moscow Police Department officer gave [REDACTED] and him a ride to [REDACTED] apartment due to her amount of intoxication. [REDACTED] walked home from [REDACTED] apartment and remained in his apartment, waking at 1300 - 1400 hours on November 13, 2022. [REDACTED] said [REDACTED] was in the apartment with him and was still there sleeping when [REDACTED] left in the afternoon hours on November 13, 2022.
4. [REDACTED] said he learned of the homicides from the news and from others in the area.
5. [REDACTED] did not know the victims and did not spend time with the college students.
6. [REDACTED] removed his sweatshirt, showing me his arms and neck. There were no marks on [REDACTED] arms, neck, or face.
