### Summary Narrative

[REDACTED] was the [REDACTED] of the sorority and provided surveillance video footage from the house, captured on November 12 and 13, 2022. Detective Sergeant T. Hopkins downloaded the footage to a memory storage device. We transported it to the Moscow Police Department and delivered it to ISP Detective J. Schwecke.

I gave [REDACTED] a memory storage device to download the footage.

3. On November 28, 2022 at approximately 6:55 p.m., Detective Sergeant T. Hopkins and I picked up the memory storage device from [REDACTED] at the house. We transported it to the Moscow Police Department the morning of November 29, 2022 and I delivered it to ISP Detective J. Schwecke.
