Narrative

- On November 23, 2022, Det. Payne authored a search warrant for the residence of a person of interest, [REDACTED], [REDACTED], [REDACTED], Moscow, ID. ISP Det. Jake Schwecke, ISP Det. Brady Walker, Det. Payne and I processed the residence.
- At about 1:37 p.m., I started a pre-evidence-processed video and photographs.
- I tested multiple red-colored stains with Hemident, a presumptive positive test for blood. Red-colored stains in the bathroom sink and near the toilet handle were negative. Red-colored stains on the shower curtain and the west entry hall wall were positive. I marked the evidence with numbered placards and photographed the exhibits. The following evidence was recorded and/or collected:
 - Exhibit 085 - Blood swab x2, collected from the bathroom shower curtain.
 - Exhibit 086 - Blood swab x2, collected from the south wall of the bathroom, below the light switch next to the toilet.
 - Exhibit 087 - Blood swab, collected from the south wall of the bathroom, above the light switch next to the toilet.
 - Exhibit 088 - Blood swab x2, collected from west wall of entry hallway near the transition of living room.
- In the bedroom closet, I located a pair of Vans shoes. I tested the soles of the shoes with Hemident. They were negative.

5. At about 2:48 p.m., I started a post-evidence-processed video.
6. At about 2:52 p.m., Det. Payne secured the scene.
7. I transported the items collected to the MPD and turned the items over to MPD evidence technician Tim Smalldridge.
8. I entered the scene photographs into evidence, located at the ISP District 2 office, and provided copies to the MPD.
