Could you coordinate dayshift and swingshift officers' search for video during downtime? We are using an app and the city's GIS system to track where we have already looked and the results.

[ArcGIS Survey123](#) can be downloaded to our department cell. Once the app is downloaded:

1. select "Manage ArcGIS connections"
2. select add connection (bottom of screen)
3. enter <https://gis.pullman-wa.gov/portal>
4. sign in using City of Pullman ADFS
5. sign in with your city login credentials ( e.g. "COP\cengle")
6. Go to your profile at the top right of the screen (your initials)
7. Select "download surveys"
8. Choose "Survey for Chris Engle"
9. Go back to the dashboard and select "Survey for Chris Engle" again
10. Touch "+Collect" to add information about a location. The rest is self-explanatory.

We are looking for video that could depict our suspect vehicle on arterials between 11/6 and 11/14. I am hoping the store managers will just upload the video straight to

fbi.gov/moscowidaho. If they can't figure that out, I can pass along a thumbdrive. WSUPD is covering their area. I covered most of Main today and will get the rest tomorrow. I could use help with Bishop south and west of Pro Mall as well as all of Grand except Mobil and Texaco. As long as officers are using the survey tool, I don't need to know what got covered - I'll just check the map.

If needed, officers can tell the managers/owners that we are helping Moscow by trying to preserve any videos that could be useful to them.

Feel free to leave my desk number 509-338-3349 for the store manager if they are not present or just load their contact info into the app.
