5. told Detectives while she was at the hotel, told them she saw someone in the house wearing a ski mask and had made eye contact with them but didn't know what was going on because she was out of it.  This struck as odd because she remembered saying she wasn't getting drunk that night.
also said in a previous point in the interview that shortly after moved into the house, she had made comments about not feeling safe at the house because of where her room was in relation to the door, and she fel she was being watched.
7. also told Detectives about an instance where Kaylee Goncalves was followed by a male while she was at Winco. She explained the male followed her in the store and out to her car. did not know any other specifics about the encounter.
8. explained the deceased and and and were pretty good about the security at the house and did not just give out the door code.
9. When asked if she could think of anybody who would want to this, told Detectives about her physics lab
, unknown phone number).  said when she emailed him about missing class, he mentioned to her on King Street and thought maybe he would have seen or heard something.  stressed out but was a good stre
