Ebay Sales Warrant

On November 26, 2022, I requested and was granted a warrant for Ebay for the sale of the following items between January 1, 2022 to present:

1. ASIN [REDACTED] 4938, Ka-Bar Full Size US Marine Corps Fighting Knife
2. ASIN [REDACTED] 4661, Ka-Bar 1217S, Leather Sheath, USMC Logo

On November 26, 2022 at approximately 1907 hours, I logged into the Ebay Law Enforcement eRequest System located at <https://le.corp.ebay.com>. I received an email from [REDACTED]@ebay.com providing me with an internal case number of [REDACTED].

On November 28, 2022 at approximately 1105 hours, I received an email from Ebay stating the files were ready to download. I logged into the portal and downloaded the files.

In examining the files, Ebay showed no (zero) purchases for the ASIN [REDACTED] 4938, Ka-Bar Full Size US Marine Corps Fighting Knife.

No subscriber information, IP Addresses, payment information, or customer records were provided.

As these user IDs are associated with a knife sheath purchase before or after November 13, 2022, I am requesting the assistance of the Latah County Prosecutor's Office to apply for a warrant for the following:
Account information for the above-named eBay UserIDs subscriber information to include: contact information, billing information, account opening date, account closing date, and any other information retained in connection with the identified accounts;
Order details and purchase history for all transactions conducted by the above-named eBay UserIDs or any eBay affiliated storefront/webstore, including IP address information for purchases made, shipping addresses, and issuing bank card used;
Payment information for payments made (or facilitated by) eBay to or from the abovenamed UserIDs including payments through eBay or eBay supported platforms;
All customer interaction records between eBay and the above-named individuals/entities and their representatives to include call notes, call recordings, emails and/or written correspondence;

I completed the warrant return receipt and affidavit. These documents were sent to the Latah County Prosecutor's Office to be returned to the court. I also emailed a copy of the receipt to Ebay [REDACTED]@ebay.com), as this was the originating email address associated with the documents.
