14. According to Kaylee was a first-time buyer, so her credit was good, she received the car loan without having to have a co-signer.
15. When contacted them about returning the car, the dealership put \$1,000 back into the credit card. Then when they found out the family was keeping the car, they took \$1,000 back out.

He told me he did try to sell Kaylee an extended warranty, but she declined. said the vehicle has a three-month warranty by after sale. is now waiting for the Rover to be returned to the family.
