4. I contacted the Spokane County Medical Examiner's Office in Spokane Washington. I spoke with Deputy Medical Investigator advised me that they did in fact have the body of Case Number and a full autopsy had been performed on November 21, 2022.
5. To told me that he had contacted mother, who told him that had been sober for the last four years, but two weeks prior to his death he had left the house (November 8, 2022) and did not return. He was found wondering the streets of Lewiston with cuts and abrasions on his torso and arms and transported to the hospital.
6. I requested copies of autopsy photographs so we could see what injuries the anonymous medical staff person was calling the FBI about. requested that I send his office the request in writing. I wrote a letter of request and emailed it to his office. A copy of that memorandum is attached to this report.
7. I received the requested photographs via email from the medical examiner's office. I transferred the photographs to a compact disc (CD) and entered them into evidence with the Moscow Police Department.
8. I also received a phone call from the Medical Examiner's Office staff asking if I needed anything further. I requested they do DNA buccal swabs of body. They told me they would, but an ISP detective would have to take possession of the swabs once they were done.
9. I contacted ISP Detective Lehman in the ISP District One offices. She drove over to the Spokane Medical Examiner's Office and picked up the buccal swabs. Detective Lehman then drove the swabs to the Moscow Police Department and placed them into evidence.
10. Case continues.
