Narrative

1. On November 28, 2022, at approximately 7:44 p.m., I, Detective Sergeant Jess Stennett of the Idaho State Police (ISP) was contacted by telephone by [REDACTED] (DOB [REDACTED]/1976). [REDACTED] was a previous [REDACTED] of mine from Meridian, Idaho. [REDACTED] asked if I was a part of the homicide investigation in Moscow, Idaho. He asked because he had received a phone call from a person who claimed to be with the FBI. [REDACTED] was somewhat skeptical because the number returned to a Detroit, Michigan area code. He contacted me because his [REDACTED] attended the University of Idaho and may have information about persons who were associated with the homicide victims.
2. [REDACTED] asked if I could reach out to his [REDACTED] (DOB [REDACTED] 2002) and talk to her about what information she may have.
3. On December 2, 2022, at approximately 11:05 a.m., Detective G. Tolleson and conducted a recorded telephone interview with [REDACTED] ([REDACTED]).
4. [REDACTED] was attending the University of Idaho and was living in Moscow, Idaho. She was the [REDACTED] of her sorority, [REDACTED].
5. [REDACTED] was classmates with Xana A. Kernodle (DOB [REDACTED]/2002). She was not close to Xana but knew her primarily through her ex-boyfriend, [REDACTED] (DOB [REDACTED]-2002). Last year while she was dating [REDACTED] she would visit Kernodle's old apartment on a weekly basis. She still saw Kernodle around campus and town, but she did not hang out with her like she previously did. She did not go to the current apartment, 1122 King Street, because [REDACTED] was there on regular basis. She added [REDACTED] was a member of the [REDACTED] fraternity.
6. [REDACTED] described seeing Ethan J. Chapin (DOB [REDACTED]/02) at the old apartment when she was there with [REDACTED] last year. She did not believe Kernodle and Chapin were officially dating at the time.

7. [REDACTED] did not know any person Kernodle was dating last year. She did know one of [REDACTED] friends and fraternity brothers had a crush on Kernodle. The individual's name was [REDACTED] (DOB [REDACTED]/2021).
8. She was not aware of anyone stalking or having issues with Kernodle.
9. She was not close to Ethan Chapin. She knew him from last year while she would visit at the old apartment with [REDACTED]. She primarily saw Chapin at [REDACTED] parties.
10. She did not know Madison Mogen or Kaylee Goncalves very well. She described going to Mogen's house one-time last year. She reiterated she didn't go to the new apartment (1122 King Street) because [REDACTED] would go there frequently.
11. She knew [REDACTED] through her roommate who played [REDACTED] with [REDACTED]. She saw her at parties but did not have a relationship with her. She described [REDACTED] last year. [REDACTED] expressed concern because she had seen [REDACTED] at parties.
12. She did not know [REDACTED] personally. She did know her sorority sister [REDACTED]. She described [REDACTED] and [REDACTED] being close friends.
13. She knew [REDACTED] (DOB [REDACTED]/2002) from hanging out last year at the old apartment but did not know much about her.
14. She recalled visiting Kernodle's old apartment last year because a friend she was close with, [REDACTED] lived next door. She described [REDACTED] and Kernodle having a close friendship.
15. She stated [REDACTED] was no longer at the university because she graduated last year. However, [REDACTED] could have been sent a text about the night of the homicide. The text was a screenshot describing two of the other roommates locking their doors because they heard someone rummaging around.
16. [REDACTED] detailed the day of November 12, 2022; the University of Idaho football team was having senior night. This was a big game and many people attended. There were many students pregaming before the game. She was not certain, but she assumed all the victims attended the game.
17. At approximately 10:45 p.m., [REDACTED] went to the [REDACTED] Kia fraternity party. At approximately 11:00 to 11:30 p.m., she briefly observed Kernodle and Chapin for about 10 to 15 minutes. She observed Kernodle and Chapin on the upper floor of the lodge. She described them on the upper floor looking down observing the party. She recalled hearing a couple songs play when she lost track of Kernodle and Chapin. The [REDACTED] Kia Party ended at 1:00 a.m.
18. After the [REDACTED] Kia party, she went to a party at the [REDACTED]. She was at the party until approximately 4:00 a.m. She described the [REDACTED] as being on the same road as Kernodle's apartment. When she left the apartment, she was walking and ran into one of her good friends, [REDACTED] (DOB [REDACTED]/2002). She believed [REDACTED] had been at Kernodle's apartment earlier that evening.
19. Her interaction with [REDACTED] occurred at the [REDACTED]. When she was walking down from the apartments, [REDACTED] was talking to a group of people. She believed [REDACTED] stayed at the [REDACTED] when she left.
20. She had seen what she described as Snap Chat videos [REDACTED] took at Kernodle's apartment earlier that evening. She provided [REDACTED] phone number [REDACTED]. [REDACTED] was going to provide [REDACTED] a ride back to Boise when she went home.
21. [REDACTED] added Kernodle was very close to the [REDACTED]. She believed we should talk to her ex-boyfriend [REDACTED]. He frequented Kernodle's apartment regularly. She did not know if he was at the apartment the night of the homicide. She provided his phone number [REDACTED].
22. She was not aware of any strange people who may be around campus. Most of the parties are policed by "Sober Bros" who are fraternity members who remain sober.
23. She described a social media app called Yik Yak which is used to post a variety of information. The posts are

anonymous and can be seen by everyone on the app in a five-mile radius. Parties are sometimes posted, but she did know if anything was posted about 1122 King Street the night of the homicide.

24. She stated many of the students use Snap Chat and have active Snap Maps. However, she did not see Kernodle or Chapin on Snap Maps from that night.

25. She described the apartments [REDACTED], Moscow, Idaho. The apartment was nicknamed [REDACTED]. She believed many people who lived at the apartment were close to Kernodle. She believed the FBI had contacted individuals at the apartment already.

26. At approximately 11:46 a.m., the interview ended.

27. On December 5, 2022, Detective Tolleson contacted [REDACTED]. [REDACTED] told Detective Tolleson he was not at King Street apartments the night of the homicide. I contacted [REDACTED] to clarify if she knew for certain [REDACTED] was at Kernodle's the day of the homicide. She told me she was mistaken. [REDACTED] had been at [REDACTED] apartment which was in the same area.

28. The recording of the interview, text message correspondence, and notes were turned over to the Moscow Police Department.
