Tim Hopkins from the Idaho State Police District 6 Investigations Office, interviewed [REDACTED] regarding a tip called into law enforcement about a homicide which occurred in Moscow, Idaho on November 13, 2022. [REDACTED] is the mother of [REDACTED]. The interview took place at [REDACTED] in Boise, Idaho. During the interview [REDACTED] told us the following:

2. She did not call a tip in. She has never called.

3. She only knows what [REDACTED] tells her. She received the text when it first happened and was concerned for

4. She learned it was four people later that night with her husband.
5. [REDACTED] has been home since the week before Thanksgiving. [REDACTED] went in for an interview with the FBI before Thanksgiving.
6. [REDACTED] was home Saturday Dec 3rd and is currently home.
7. [REDACTED] has been good, and he is a good, very responsible kid. Frat life has been good to [REDACTED]
8. Moscow is a small community, they all work, play and go to school together. [REDACTED] knew the victims and was friends with them. Xana was familiar with [REDACTED] frat house. [REDACTED] knew all three girls and was familiar with Ethan.
9. As far as she knows they were all friends.
10. [REDACTED] went to Cabo with his frat brothers.
11. [REDACTED] is a pretty honest person. [REDACTED] is not too attached with any girl. He is friendly with a lot. The girls seem to like him.
12. She does not know of [REDACTED] getting into trouble.
13. [REDACTED] was at the day party at the [REDACTED]
14. [REDACTED] left the party to get something to eat and drink, then he went back to the frat house.
15. [REDACTED] should have alibis because he took the fraternity DD. Someone is there to corroborate his whereabouts.
16. She does not know what type of room [REDACTED] has at the Frat house. [REDACTED] has talked about how his room is set up.
17. [REDACTED] was the [REDACTED] on the frat [REDACTED] last year. She does not think [REDACTED] is on [REDACTED] this year.
18. The frat was on suspension from events a couple of years ago. The current members have to clean up from the past.
19. A lot of the frat life is over her head.
20. She thinks it's a little disconcerting someone would call in this tip. Her phone number is [REDACTED]
21. [REDACTED] has a white [REDACTED] [REDACTED] he drives at school. He does not drive it very much.
22. [REDACTED] uses the designated driver for the frat.
23. As far as she knows [REDACTED] was at the frat house playing video games with a bunch of friends the night of the homicide. She thinks there was one or two of [REDACTED] friends playing video games with him. One of [REDACTED] friends wanted to go out, but [REDACTED] stayed in to play video games.
24. Her husband's phone number is [REDACTED].
