Narrative

1. I, Idaho State Police Detective Sergeant Michael Van Leuven, had first called [REDACTED] (DOB [REDACTED]-2000) on December 4, 2022. He said he was in Dallas, Texas and would be back to Coeur d'Alene the following Tuesday when he would come in for an interview. [REDACTED] called back on 12-6-2022 and agreed to come in the following day for the interview.
2. On December 7, 2022, FBI Special Agent M. Zahaczewsky and I interviewed [REDACTED] [REDACTED] regarding his presence in Moscow on the weekend of the homicides as well as his relationships with some of the victims. This was both an elimination interview as well as a victimology interview. [REDACTED] was completely cooperative and friendly throughout this process.
3. [REDACTED] consented to give a DNA sample which I took using Buccal swabs. I later transferred those swabs to the Moscow Police Department (MPD).
4. [REDACTED] also consented to download his phone for forensic examination. This was done while the interview was conducted. This phone number was [REDACTED]. A copy of this download was provided to MPD. I have scanned the consent form and placed a scan on a disc which will be transferred to MPD.
5. [REDACTED] name had come in through tip #5594. The information in this tip alleged that [REDACTED] resides in Coeur d'Alene and frequently visits Moscow where he stays in a travel trailer. The tip further alleges that [REDACTED] is acquainted with victims Kaylee J. Goncalves (DOB [REDACTED]-2001) and Maddie M. Mogen (DOE [REDACTED]-2001) and had pressured them to join him at this trailer on the night before the murders, but they refused. The tip further alleges University of Idaho student [REDACTED] had refused [REDACTED] advances over Labor Day weekend and that [REDACTED] became violent and threw a vape at her.
6. [REDACTED] said he lives in Coeur d'Alene and works at the [REDACTED] in the [REDACTED] department. [REDACTED] said he had traveled to Moscow for the November 12-13th weekend. He said he had traveled to Moscow for the purpose of attending the University of Idaho football game in which his friend [REDACTED] [REDACTED] played for the Vandals. [REDACTED] advised he had traveled to the game with [REDACTED] parents who pulled their travel trailer for the game.
7. [REDACTED] said he knew Goncalves, Mogen and Xana Kernodle (DOB [REDACTED]-2002) from [REDACTED]. [REDACTED] said he, Goncalves and Mogen all attended [REDACTED] together and Kernodle had attended school in [REDACTED].

Post Falls. [REDACTED] related that he had several friends that were students at the University of Idaho. [REDACTED] said he had talked to Goncalves but that they had never dated. He said Goncalves and Mogen mostly stuck to their own friend group.

8. [REDACTED] said he had Snapchated Mogen to see if they wanted to hang out. Mogen said they were going to a Greek party. [REDACTED] said he and his friends could not go because they were not Greek.

9. [REDACTED] said his friend [REDACTED] lived in the [REDACTED] in Moscow and that after the game he had hung out at the [REDACTED] trailer for a while and then had gone to [REDACTED] apartment.

10. [REDACTED] said he ended up going to an off-campus party at a house northeast of the [REDACTED] apartments that he referred to as a golf party because University of Idaho Golf players lived there. He said most of the people that were at this party were student-athletes from the University of Idaho.

11. [REDACTED] said immediately after the game they had hung out at [REDACTED] parents' trailer. After that, at approximately 8 or 9:00 p.m., they left to go to the golf house party. [REDACTED] said he estimated 50 to 100 people were present for that party. [REDACTED] said he stayed at that party for approximately 4 hours and then went back to [REDACTED] apartment between one and two a.m. [REDACTED] said [REDACTED] had a friend who was a female [REDACTED] named [REDACTED] who had an apartment near [REDACTED]. [REDACTED] said he, [REDACTED] and some other friends went to [REDACTED] apartment and hung out there. [REDACTED] said that he ended up sleeping at [REDACTED] apartment that night. [REDACTED] said a couple of other girls had shown up at [REDACTED] apartment that night, but he did not know their names.

12. [REDACTED] said he never went to the house where the homicides occurred and had no additional contact with the girls that night. [REDACTED] said he tried calling Mogen the next day.

13. [REDACTED] filled out a victim background questionnaire. I scanned this and placed it on a disc. The original will be transferred to MPD. [REDACTED] provided additional victimology information.

14. The interview and phone call setting up the interview was audio recorded. I placed these recordings on the same disc to be transferred to MPD.
