KaBar Warrant

On December 4, 2022, I found I had received an email forwarded to me from E [REDACTED] M [REDACTED] of Cutco Corporation, the parent company of KaBar knives. The email was from Michael Douglass of the Federal Bureau of Investigation. SA Douglass assisted in the service of the warrant to KaBar.

The email contained a single file with the data requested pursuant to the warrant served on KaBar. The file was downloaded and saved onto a computer located in the secure computer forensic lab located at the Moscow Police Department.

In examining the file, I located numerous individuals and companies who had purchased products matching the descriptions in the warrant. In the state of Idaho, the following sales of 1217 knives were located:
