**Narrative**

1. On December 6, 2022, at approximately 1630 hours, I, Idaho State Police (ISP) Detective Brady Walker, along with ISP Detective Gary Tolleson, interviewed [REDACTED] [REDACTED] (DOB [REDACTED]/2002) at the Moscow Police Department. [REDACTED] had been in the [REDACTED] [REDACTED] as Goncalves and initially contacted the tip line regarding a potential stalker situation. [REDACTED] completed a written Adult Victim Background Questionnaire and was subsequently interviewed. Detective Tolleson recorded the interview.

2. The following is a summary of the information discussed. For exact details, refer to the questionnaire, the audio recording, and the media provided by [REDACTED]

3. [REDACTED] did not know Goncalves' mother's name, but Goncalves spoke to [REDACTED] about the fights she and [REDACTED] had. [REDACTED] described them as "average" [REDACTED] fights, such as Goncalves needing to pay for her own phone. When Goncalves was in her freshman year, she did not get along with [REDACTED]. [REDACTED] had not met Goncalves' [REDACTED].

4. Goncalves and her boyfriend [REDACTED] had a very positive relationship. Whenever they broke up, it was always her (Goncalves). When she would break up with [REDACTED] she never seemed mad about it, and would hang out with the sorority sisters more. [REDACTED] described [REDACTED] as shy.

5. [REDACTED] described Goncalves as the most "down to earth person" with a contagious smile. After Goncalves dropped from the sorority, she started hanging out with [REDACTED] more, but their relationship would pick up where it left off when they would see each other.

6. [REDACTED] could not recall any significant events prior to Goncalves' death. Goncalves drank "the normal average" for a college student and was not into drugs. She did not engage in abnormally risky behavior. When [REDACTED] saw Goncalves, she was frequently doing homework.

7. Goncalves was closest to Madison Mogen, but [REDACTED] listed several people in her sorority she was also close to. [REDACTED] listed them as [REDACTED] (believed to be [REDACTED], DOB [REDACTED]/2001), [REDACTED] (unknown further), and [REDACTED] (believed to be [REDACTED], DOB [REDACTED]/2001). [REDACTED] was Goncalves' [REDACTED] which was described as a [REDACTED]

8. [REDACTED] did not recall an instance where Goncalves expressed discomfort or fear about anyone. When she and [REDACTED] would break up, Goncalves wouldn't be upset. [REDACTED] believed Goncalves was always the one that ended things due to her being bored with the relationship. At one point when she and [REDACTED] broke up, she had an interest in [REDACTED] who is a U of I student and lives in Coeur d'Alene. This is believed to be [REDACTED] [REDACTED] [REDACTED] (DOB [REDACTED]/2002). [REDACTED] did not know anyone who disliked any of the victims.

9. [REDACTED] described an incident involving [REDACTED] (DOB [REDACTED]/2000) when she lived at [REDACTED] which is directly below 1122 King Road, and the [REDACTED] [REDACTED] phone number is [REDACTED]. Once at the [REDACTED] [REDACTED] and her roommates came out to the kitchen to find the dishwasher clean/dirty sign changed to "fuck off -Jeff" with a steak knife bent in half next to it. None of the occupants had any idea who "Jeff" would be.

10. While [REDACTED] was living at [REDACTED] [REDACTED] she had returned from Boise and left her suitcase in the car. When she came out in the morning, someone had moved the personal effects from the front of her car (such as lip gloss and other accessories) had been moved into her suitcase. Her suitcase was removed from the vehicle and left in the middle of the cul-de-sac. Nothing was taken except for her underwear. A footprint was found on the seat of her car. [REDACTED] reported the incident to Moscow Police. The night after the car burglary, [REDACTED] and her roommate were the only ones home, but heard someone walking around upstairs very slowly.

11. [REDACTED] sent two screenshots of the text conversation with [REDACTED]. The screenshots were saved on a USB drive under Supplement 065.

12. [REDACTED] described [REDACTED] [REDACTED] as more strict for party attendance, as in you had to be invited or be part of the

function to attend. 1122 King Road was more lax in that respect.

13. [REDACTED] recounted several instances where she believed she was being watched by a male who went by [REDACTED]. [REDACTED] believed [REDACTED] lived in the [REDACTED] [REDACTED] [REDACTED]. [REDACTED] described [REDACTED] as a white male in his thirties with a [REDACTED] beginning to bald on top. He was about [REDACTED] and had a large, but not muscular, stature. [REDACTED] saw [REDACTED] walking around the sorority house several times. When she would return from going on a run, [REDACTED] would appear behind her.

14. [REDACTED] would have to walk in front of these apartments on the way to her sorority and began getting messages on Instagram from username [REDACTED] as she was passing by. From September 1 to September 15, 2020, this user sent several messages. The user seemed to believe that [REDACTED] would smile and wave at them. [REDACTED] blocked the user on September 15, 2020. [REDACTED] sent screenshots of the conversation and of a picture of a male on the profile. [REDACTED] said the profile had since been removed from Instagram.

15. The audio recording of the interview will be saved under a folder associated with Supplement 065 and submitted to evidence at Moscow Police Department. The tip information, as well as the adult victim background questionnaire, was scanned and attached to this supplement.

16. End of report.
