**Narrative**

1. On December 3rd, 2022, Idaho State Police Detectives conducted surveillance at [REDACTED] in Boise, Ada County, Idaho. The surveillance operation was conducted on a potential homicide suspect identified as [REDACTED] (DOB: [REDACTED]/2001).

2. At approximately 11:55 p.m., surveillance units set up around the residence. Idaho State Police Detective C. Pohanka observed three vehicles parked at the residence. The following vehicles were observed:

a. Silver [REDACTED] bearing Idaho license plate [REDACTED] registered to a [REDACTED] in Boise, Idaho.

b. White [REDACTED] bearing Idaho license plate [REDACTED] registered to a [REDACTED] in Boise, Idaho.

- c. Silver [REDACTED] bearing Idaho license plate [REDACTED] registered to a [REDACTED] in Boise, Idaho.
3. At approximately 5:43 p.m., Detective C. Pohanka observed an individual believed to be [REDACTED] leave the residence in the silver [REDACTED]. [REDACTED] took multiple routes in a random manner. The routes ultimately took surveillance units in multiple circles around the Boise area. At approximately 6:32 p.m., Detective C. Pohanka observes [REDACTED] return to his house on [REDACTED] drive.
4. At approximately 8:11 p.m., Detective C. Pohanka observes an individual believed to be [REDACTED] leave the residence. Surveillance units followed [REDACTED] to a [REDACTED] gas station located at [REDACTED] in Boise, Idaho. Idaho State Police Detective Sergeant D. Cortez observed what appeared to be [REDACTED] go into the gas station. At approximately 8:23 p.m., [REDACTED] left the gas station and drove to a residence near [REDACTED] Street in Boise, Idaho and parked on the street. [REDACTED] did not get out of the vehicle.
5. At approximately 8:30 p.m., Sergeant D. Cortez observed an individual get into the [REDACTED] with [REDACTED] and leave together.
6. At approximately 8:36 p.m., [REDACTED] and his passenger arrived back at the same [REDACTED] gas station on [REDACTED]. Sergeant D. Cortez observed [REDACTED] and the passenger exit the vehicle and go into the gas station.
7. At approximately 8:41 p.m., [REDACTED] and his passenger left the [REDACTED]
8. At approximately 8:46 p.m., surveillance units followed [REDACTED] to an apartment complex near the intersection of [REDACTED] in Boise, Idaho. All occupants of the vehicle got out and went into the complex.
9. At approximately 9:30 p.m., surveillance ended.
10. On December 4th, 2022, Idaho State Police detectives set up surveillance on [REDACTED] Boise, Idaho.
11. At approximately 3:44 p.m., Detective C. Pohanka observed an individual believed to be [REDACTED] leave with his mom in the [REDACTED]. Surveillance units followed them to the [REDACTED] located at [REDACTED] in Boise, Idaho.
12. Idaho State Police Detective Sergeant T. Hopkins followed [REDACTED] inside and attempted to positively identify him. Detective T. Hopkins identified someone who looked like [REDACTED] but later was identified to be [REDACTED] brother [REDACTED]
13. At approximately 4:17 p.m., [REDACTED] and his mother arrived back at their house.
14. At approximately 4:58 p.m., Idaho State Police Trooper A. Weinstein observed an individual appearing to resemble [REDACTED] leave the residence in the silver [REDACTED]. Detectives followed the vehicle to the [REDACTED] gas station located at [REDACTED] in Boise, Idaho and watched [REDACTED] pump gas into the [REDACTED].
15. Detectives followed [REDACTED] towards the Boise St. Lukes. [REDACTED] eventually turned up Warm Springs where detectives eventually lost sight of him. Detective Sergeant R. Hoxie eventually found [REDACTED] and observed he had a passenger with him.
16. At approximately 5:28 p.m., [REDACTED] arrived at [REDACTED] where Sergeant D. Cortez observed a male get into the vehicle. At approximately 5:31 p.m. the vehicle left and arrived at the parking lot behind [REDACTED] located at [REDACTED] in Boise, Idaho.
17. Sergeant D. Cortez observed everyone exit the vehicle and they went inside the gas station. At approximately 5:44 p.m., everyone got back into the vehicle and left the gas station.
18. At approximately 5:48 p.m., detectives followed [REDACTED] to a house located at [REDACTED] in Boise, Idaho where all occupants went inside.
