interviewed [REDACTED] (DOB [REDACTED]/2003) in continuation of the homicide investigation in Moscow, Idaho. [REDACTED] name was reported via the tip program as a person who knew Ethan Chapin and was described as "odd". I called [REDACTED] who agreed to come to the ISP District One office in Coeur d'Alene to be interviewed. I began the interview at 1353 hours.

2. [REDACTED] said he was no longer attending University of Idaho (U of I) as he was preparing to leave North Idaho to join the Navy. [REDACTED] confirmed his current address at [REDACTED] Rathdrum, Idaho 83858.

3. [REDACTED] was roommates and [REDACTED] with [REDACTED] [REDACTED] who was [REDACTED], reporting the unresponsive persons at 1122 King Street on November 13, 2022.

4. [REDACTED] said he spent a great deal of time at the apartment at 1122 King St. [REDACTED] said he, [REDACTED] and [REDACTED] girlfriend [REDACTED] are close friends with victims Xana Kernodle and Ethan Chapin. [REDACTED] said there are many members of the U of I Greek community who spent time in the 1122 King Street apartment eating and partying. [REDACTED] said the apartment was frequented by [REDACTED] and [REDACTED]

5. [REDACTED] was a member of the [REDACTED], but he had "dropped" during the first week of this year. [REDACTED] was still active in the Greek groups, including [REDACTED].

6. [REDACTED] lived at [REDACTED] in Moscow. [REDACTED] were [REDACTED] and [REDACTED] said [REDACTED] had gone to Mexico following the murders and was now in Boise. [REDACTED] and [REDACTED] were still residing at the apartment in Moscow.

7. On November 12, 2022. [REDACTED] said he was staying in [REDACTED] with his father so he could purchase a new phone. [REDACTED] went back to Moscow on November 13; driven by his father, he arrived back at his apartment at 0800 hours. The early drive to Moscow was not unusual for his father due to his work schedule. [REDACTED] and his father bought groceries and [REDACTED] was dropped off. [REDACTED] spent the morning catching up with [REDACTED] boyfriend, [REDACTED] and [REDACTED]. The group was saying goodbye to [REDACTED] who was leaving at 1100 hours to transfer to Boise for graduate school.

8. [REDACTED] said he was hanging out on the couch when [REDACTED] said he was going to go check on [REDACTED] and [REDACTED] at their apartment (1122 King St.) [REDACTED] said [REDACTED] girlfriend, [REDACTED] went with him to the 1122 King Street apartment. [REDACTED] lived [REDACTED] did not know why [REDACTED] was going to check on [REDACTED] and [REDACTED] and was not told who asked [REDACTED] to go to the apartment. Shortly after [REDACTED] left, the police activity in the area began.

9. [REDACTED] last saw Kernodle approximately three days prior to November 13, 2022, at [REDACTED] apartment confirming he left for [REDACTED] on the Wednesday prior to the murders. [REDACTED] saw Chapin the same day as Kernodle and also played internet video games (Apex Legends) with Chapin and [REDACTED] on November 12, 2022, at approximately 1830 hours before everyone went out.

10. [REDACTED] considers himself an acquaintance of Madison Mogen and Kaylee Goncalves and did not know them very well.

11. [REDACTED] does not think he is on social media with any of the victims but would be in pictures of a trip to Priest Lake with Chapin.

12. [REDACTED] was in the 1122 King Street apartment in the early part of the week of the 7th of November. [REDACTED] has been in several of the rooms within the apartment.

13. [REDACTED] texted Chapin after he learned of reports of an incident at 1122 King Street but did not have any communication with any of the victims in the forty-eight hours leading up to the homicides.

14. [REDACTED] could not speak to any knowledge of the victims feeling unsafe.

15. [REDACTED] said there are fist fights in his apartment complex and in the parking lot. [REDACTED] has witnessed two of the fights. [REDACTED] was involved in one in which an unknown male walked into his apartment and punched him in the face. Other people with the male broke up the fight. [REDACTED] said the fight was in

- September. ██████████ has never seen the unknown male, or his friends in the area again.
16. ██████████ said he kept the door of his apartment locked due to the amount of drunk people around the area.
 17. ██████████ said he knew most of the people that live in the area of 1122 King Street and cannot think of anyone who could commit the murders. ██████████ knew the back sliding door of 1122 King Street is always left unlocked and many people are aware of that.
 18. ██████████ is friends with ██████████ and ██████████ the surviving roommates at 1122 King Street and usually hung out with them in a group of friends.
 19. ██████████ volunteered DNA samples and I secured the buccal swabs.
 20. The audio of the interview was saved to a disc. The disc and the buccal swabs were packaged and signed over to ISP Detective Sergeant Michael VanLeuven for transport to the Moscow Police Department.
