On November 14, 2022, at around 1710 hours, I contacted E [REDACTED] G [REDACTED] in the front lobby of the police department. G [REDACTED] had contacted Moscow PD earlier in the day and stated he is a local Uber driver and he gave Kaylee and Maddie a ride home on 11-13-22 from the downtown area. G [REDACTED] had been in the Spokane/Coeur d'Alene area when he contacted us and stated he would not be back until 1700 hours.

I asked G [REDACTED] how he knew Kaylee and Maddie. G [REDACTED] stated he drives for Uber and Lyft and Kaylee and Maddie have become some of his regular customers and this is how he meet them.

G [REDACTED] stated he was contacted by Kaylee on 11-12-22 at around 2202 hours and asked if he could pick her and some friends up at 1122 King Road and take them to the Corner Club. G [REDACTED] arrived at the address at 2015 hours and picked up Kaylee, Maddie, and one other female. G [REDACTED] stated at 0145 hours on 11-13-22 he was contacted by Kaylee again and asked if he could pick her and some friends up at the Grub Truck. G [REDACTED] arrived at the Grub Truck at around 0149 hours. G [REDACTED] took Kaylee and Maddie home, he stated it was a 3 to 4 minute drive from the Grub Truck to 1122 King Road.

G [REDACTED] told me he has been driving for Uber and Lyft since 2019. G [REDACTED] told me Kaylee has been a regular for at least the last year. G [REDACTED] stated he was working but Kaylee did not contact him through the Uber or Lyft app but instead texted him directly both times.

G [REDACTED] stated when he got to the Grub Truck he parked in front of the Grub Truck on Main Street facing south. G [REDACTED] texted Kaylee he was there and she stated they would be there in a second and said they were at order 75 and theirs was 78. Kaylee and Maddie came to the vehicle a short time later. Kaylee was in the front passenger seat and Maddie was in the rear seat. Maddie was eating the food from Grub Truck with her hands. They all had a casual conversation. G [REDACTED] stated they appeared to be fine and nothing appeared to be out of the ordinary.

G [REDACTED] stated he still had the texts on his phone and he sent screen shots to me. I burned those screen shots to a DVD and booked it into property at a later time along with other documents I had related to this case.

G [REDACTED] was not able to give me more information at that time.
