Interview with S [REDACTED] E [REDACTED]

On 12/13/22 at approximately 2000 hrs. I interviewed S [REDACTED] E [REDACTED] in [REDACTED] Idaho at the [REDACTED]. E [REDACTED] had called me several days earlier to report some information he had regarding the quadruple homicide.

I asked E [REDACTED] if the information he would be sharing would be dealing with one person. E [REDACTED] told me it would. I asked E [REDACTED] if I could get the individuals name. E [REDACTED] told me the persons name was G [REDACTED] or G [REDACTED]. Later identified as (G [REDACTED] M [REDACTED], [REDACTED]-2003) E [REDACTED] told me he did not know the individuals last name, but believed he knew where he lived. E [REDACTED] told me he lived in the [REDACTED] Apartments. E [REDACTED] told me this apartment is just off of [REDACTED] Ave, then turn onto [REDACTED] Lane and then right onto [REDACTED] St. and the apartment is across from the [REDACTED] [REDACTED] E [REDACTED] told me G [REDACTED] lives in the [REDACTED] apartments.

E [REDACTED] began by explaining to me that he had done a lot of work for D [REDACTED] K [REDACTED] who is the prior owner of [REDACTED]. E [REDACTED] told me he has been a friend of the family for many years and has done handyman jobs in the past for D [REDACTED]. E [REDACTED] told me in 2020 he drove D [REDACTED], his daughter L [REDACTED], and G [REDACTED] up to [REDACTED] to a place the family goes to have a vacation almost every year. E [REDACTED] told me after they got there, R [REDACTED] who is one of D [REDACTED] sisters, got into an altercation with a male who was camped near where they were. E [REDACTED] told me it was a heated argument but everyone eventually went back to their camp sites. E [REDACTED] told me later in the evening he noticed R [REDACTED] and L [REDACTED] were walking past the male's camp site so he went and went up on the hill where he could observe and make sure nothing was going to happen. E [REDACTED] told me he had been up on the hillside for several minutes in the dark when all of a sudden G [REDACTED] just appeared out of nowhere. E [REDACTED] told me it startled him for a minute because he never heard or saw where G [REDACTED] came from. E [REDACTED] told me G [REDACTED] pulled out a knife to show him.

E [REDACTED] told me this was hunting style knife. E [REDACTED] told me he had spoken to

G [redacted] who had showed a great interest in having a career in the Military. I asked P [redacted] if he could describe the knife to me. P [redacted] told me it was a typical 7 inch blade hunting/skinning knife.

P [redacted] told me he had heard that G [redacted] grades in school had dropped and that I [redacted] had been extremely verbally abusive to him.

I asked how I [redacted] and G [redacted] would travel to Moscow from Boise. P [redacted] told me he believed they would ride the bus when they traveled. P [redacted] told me when they stayed in Moscow at D [redacted] house, G [redacted] and his sister would stay in the basement and I [redacted] would sleep outside or in one of the two sheds in the back yard.

P [redacted] told me the significance of this was that G [redacted] would keep his knives in the basement of D [redacted] house, in the wood pile that was outside, or in one of the two sheds in the back yard.

P [redacted] told me around the end of May, or sometime into the middle of June, after COVID was letting up, he was at the Mad Greek having a late lunch or early dinner. P [redacted] told me this was on a Saturday or a Sunday. P [redacted] told me he had ordered a glass of wine which he is sure that Ethan brought him. P [redacted] told me he is not sure if Ethan worked at Mad Greek or was just helping out. P [redacted] told me a bit later he noticed that G [redacted] had come into the restaurant with possibly D [redacted] who is G [redacted] cousin. P [redacted] told me Xana and Madison had gone over to G [redacted] table and Ethan later joined them.

P [redacted] told me it appeared to be a heated conversation but he could not tell what it was about. P [redacted] suspected it may have had to do with the "Cancel Culture." and that G [redacted] was stirring them up with conservative comments. P [redacted] told me G [redacted] left without eating anything.

Later that night around 9pm-10pm P [redacted] was at D [redacted] house in his backyard. P [redacted] said that I [redacted] was extremely drunk and she was yelling at G [redacted]. P [redacted] said she stated, "You are just a looser and you are going to spend your life in jail, you are ruining your life." P [redacted] was not sure what I [redacted] was referencing when she said this. P [redacted] told me G [redacted] left right after this altercation and he did not see him again. P [redacted] told me G [redacted] goes on long walks and does not return until the early morning hours.

P [redacted] told me he was over at D [redacted] the next morning picking up some tarps from a job he had been doing and G [redacted] showed up. P [redacted] told me he asked G [redacted] what he does after he leaves when his mom is yelling at him. G [redacted] told him he goes over to the college. P [redacted] told me G [redacted] believes the college is to blame for how his mom is. P [redacted] explains that I [redacted] went to parties at the college and began drinking. P [redacted] told me he does not know for sure but believes that I [redacted] may have been raped at one of the college parties.

P [redacted] told me he asked G [redacted] about the conversation that took place at the Mad Greek Restaurant. P [redacted] said that G [redacted] told him that he had followed the girls to the Mad Greek from the college. G [redacted] told P [redacted] that the two girls were lesbians. G [redacted] told P [redacted] he had went back to the girls' house and when they came home he was inside the house and made the statement, "They had no idea that I was there, I could have killed them all if I had wanted to."

P [redacted] told me G [redacted] then went and got a larger knife from out of the back shed and showed him.

F[REDACTED] told me every time he was around G[REDACTED] and G[REDACTED] mom would explode on him he always stayed very calm and would not react to her.
