Summary Narrative

On December 14, 2022, at about 2:00 p.m., Idaho State Police (ISP) Detective (Det.) Ryan O'Harra and I, ISP Det. and Federal Bureau of Investigation (FBI) Task Force Officer (TFO) Gideon Roberts interviewed [REDACTED] at the Moscow Police Department (MPD) regarding his activity on the evening of November 12 and early morning of November 13, 2022. [REDACTED] confirmed it was his vehicle, a white [REDACTED] (Idaho registration: [REDACTED]), captured on video camera as he returned home to [REDACTED] Moscow, Idaho around 2:48 a.m. on November 13, 2022. Two subsequent interviews affirmed [REDACTED] account.

Narrative

1. On December 14, 2022, at about 2:00 p.m., ISP Det. O'Harra I interviewed [REDACTED] [REDACTED] regarding his activity on the evening of November 12 and early morning of November 13, 2022. Listen to the audio recording for full details of the interview. After being advised of the purpose of the interview [REDACTED] provided the following information:
- A. On the evening of November 12 until about 2:30 a.m. November 13, 2022, he was "bar hopping" with his friends [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. He and [REDACTED] had a drink at Hunga Dunga, then walked to Mingles where they shot pool most of the evening and were joined by [REDACTED] there, then continued to John's Alley and stayed there until it closed around 2:30 a.m.
- B. After the bars closed, they walked to [REDACTED] house near Pizza Perfection, where he "...sobered up..." before driving his [REDACTED] home.
- C. After he arrived home, he went to bed and slept until about 9:00 a.m.
- D. Once he woke up, he took his garbage to the dumpster, noting it was overfull and needed to be emptied.
- E. He returned to his apartment and ate breakfast.
- F. He did not know any of the victims, nor did he have any contact with them.
2. At about 5:00 p.m., I spoke with [REDACTED] by telephone (phone). [REDACTED] affirmed [REDACTED] timeline of November 12 and 13, 2022 by providing the following information:
- A. He and [REDACTED] had dinner at Rants and Raves around 5:00 to 6:00 p.m., then went to Mingles, where they were joined by [REDACTED] until it started to "...slow down...", then continued to John's Alley until closing around 2:30 a.m.
- B. After leaving John's Alley, he and [REDACTED] walked to his residence.
- C. [REDACTED] drove home around 2:30 to 2:45 a.m.
- D. He did not know any of the victims and he had not had any contact with any of them, however, a student in his class, [REDACTED] [REDACTED] did notify him he would not be at class because he was a friend of one of the students and would be attending the memorial service.
3. On December 15, 2022, at about 8:30 p.m., I spoke with [REDACTED] by phone. [REDACTED] affirmed [REDACTED] and [REDACTED] account of November 12 and 13, 2022 by providing the following details:
- A. [REDACTED] met [REDACTED] and [REDACTED] at Mingles around 8:00 p.m., where they stayed playing pool and drinking until about midnight.
- B. They then walked to John's Alley where they had a "...a few more drinks..." and stayed there until closing, around 2:00 or 2:30 a.m.

C. Once the bar closed, he parted ways with [REDACTED] and [REDACTED] as they began walking towards [REDACTED] residence, while he began hitchhiking home, located on [REDACTED] in Moscow, until someone gave him a ride to the [REDACTED], located across the street from his residence.

D. Once he was home, he ate some food and then went to bed, where he stayed until about 12:00 p.m.

E. He did not know any of the victims and had not had any contact with any of them.

4. On December 15, 2022, I processed the recorded audio into evidence and transferred it to MPD Evidence Technician Tim Smallridge.
