Narrative

1. On December 15, 2022, at about 12:00 p.m., ISP Det. Ryan O'Harra and I interviewed [REDACTED] at the Moscow Police Department (MPD) regarding her vehicle, a [REDACTED] (Michigan registration: [REDACTED]) and her activity on November 12 and 13, 2022. [REDACTED] provided the following information:

A. She has been living at [REDACTED] Moscow, Idaho since about August 13, 2022.

B. She is currently completing her master's in [REDACTED] and is studying [REDACTED] at the [REDACTED]

C. On November 12, 2022, she ate dinner at about 5:00 to 5:30 p.m., before returning home in her [REDACTED] at about 8:00 to 8:30 p.m.

D. She did not leave her apartment for the remainder of the evening, and went to bed around 10:00 to 10:30 p.m.

E. After she awoke the following morning, she went for a walk around 7:00 to 7:15 a.m., passing by 1122 King Street and continued onto Taylor before returning home. She didn't notice anything unusual, other than it seemed to be "...especially quiet..." that morning.

F. At about 8:30 a.m. she went to church, and didn't return home until about 3:00 p.m.

G. She confirmed the above noted vehicle was hers, and no one else used or had access to her vehicle.

H. She didn't know any other the victims or have any contact with them.

2. On December 16, 2022, at about 11:45 a.m., Det. O'Harra and I interviewed [REDACTED] at the MPD regarding his silver [REDACTED]-V (Idaho registration: [REDACTED]) and his activity on November 12 and 13, 2022. [REDACTED] provided the following information:

A. He confirmed the above noted vehicle was his, and no one else used or had access to the vehicle, other than his father in Lewiston who has a spare key, but he knew his father didn't use the vehicle.

B. Other than to possibly go grocery shopping midmorning, he didn't go anywhere on November 12, 2022, spending the majority of the day playing games in his room.

C. He went to bed around 11:00 p.m. to 12:00 a.m. because he had to work at [REDACTED] the following morning at 9:00 a.m.

D. He didn't note anything unusual until he was alerted by the "Vandal Alert" of the homicides while he was at work.

E. His roommate, [REDACTED] [REDACTED] was also home on November 12, 2022.

F. [REDACTED] phone number was [REDACTED]

G. He didn't know any of the victims or have any contact with them.

3. I attempted multiple times to interview [REDACTED] but was unable to due to his failure to contact me.
