Narrative

2. Officer Lonien emailed a copy of [REDACTED] writing from November 2022. The body of the text was mostly incoherent. Officer Lonien said the totality of the writing was over one hundred pages and seemed to be written as dated entries, like a diary.

3. I was able to contact [REDACTED] by phone on January 5, 2022. The phone interview was audio recorded. [REDACTED] knew I was calling regarding the documents he sent to the Rochester Mayo Clinic. [REDACTED] confirmed

he sends documents to many government entities, attorneys, and law enforcement agencies. [REDACTED] seemed to have concerns or delusions regarding electronic devices. [REDACTED] was able to maintain the conversation, and his speech was clear and understandable. [REDACTED] said he delivered documents to the ISP Coeur d' Alene office in October of 2022.

4. No further action was taken regarding [REDACTED]

5. The recording of the phone interview with [REDACTED] and the emails and attachments exchanged with Officer Lonien have been saved to a disc and provided to the Moscow Police Department to be attached to the case file under this supplement.
