Pullman PD Injury Accident video review:

On 11-12-2022, at approximately 2340 hours, Whitcom received a hit and run accident in the area of [REDACTED] Pullman, WA (DR# [REDACTED]). Multiple PPD officers arrived on scene and blocked off the area where this incident occurred. The location of this accident was near the west entrance to the [REDACTED] Apartment Complex, near Kohberger's residence.

C [REDACTED] F [REDACTED] was later arrested as the suspect in this case and booked into Whitman County Jail. F [REDACTED] was booked into Whitman County Jail 11-13-2022 at 8:54 AM.

On January 3, 2023, K [REDACTED] I [REDACTED], the Pullman PD Records Specialist, sent me a link to PPD Evidence.com so I could view and download the videos related to this case. I downloaded 35 videos which spanned between 11-12-2022 at 2341 hours to 11-13-2022 at 0325 hours. A majority of the videos were in the area of where the suspect vehicle was eventually located, NE California St. [REDACTED] I provided the downloaded videos to Det. Mowery so he could upload them to MPD evidence server.

I later viewed the videos. I did not see a vehicle matching Kohberger's vehicle in any of the videos on Brandi Way or in the videos near NE California St. The longest video recording on Brandi Way starts at 2343 hours and runs for 1 hour 21 min. All of the videos, captured on Brandi Way, span from 11-12-2022 at 2341 to around 11-13-2022 at 0100 hours. Brandi Way was closed off with cones and police tape from 11-12-2022 around 2341 hours until 11-13-2022 at 1230 hours so the scene could be processed (Det. Sgt. Chris Engle told me NE Brandi Way was cleared by 11-13-2022 at 1230 hours). This included the west entrance to the [REDACTED] Apartment Complex, which had police tape across the entrance. The east entrance to [REDACTED] Apartments was still available for access to the complex.

While reviewing Kohberger's cell phone data extraction I located a screen shot of the Whitman County Jail Roster with C [REDACTED] F [REDACTED] information. The last modified date/time for the image was 11-13-2022 @ 6:27:12 PM. This image was taken from YikYak.

In Kohberger's Chrome tab History, on his phone, I located where he searched Google for: Broadcastify.com/listen/feed, Pullman police and fire dispatch live

audio feed, on 11-13-2022 at 12:26:49 AM.
