**Narrative**

- On Monday, January 6, 2023, I, Idaho State Police (ISP) Senior Detective Gary Tolleson, along with ISP Senior Detective Sean Prosser interviewed [REDACTED] is a [REDACTED] of the [REDACTED].
- The interview was conducted on the [REDACTED] in the [REDACTED], room [REDACTED]. The interview was recorded with [REDACTED] knowledge and permission.
- [REDACTED] told us that he had contact with Brain KOHBERGER because KOHBERGER was a student seeking a Criminal Justice Doctorate at [REDACTED]. They had met several times to discuss requirements for KOHBERGER's Doctorate studies. They also met twice in social settings, once at a bar-b-que [REDACTED] for the new students and a Holiday (Christmas) event at the college.
- [REDACTED] described KOHBERGER as "socially awkward" around people. He did not see any other behavior that he thought was odd but did tell us that KOHBERGER was removed from [REDACTED] because of his rudeness and unprofessional behavior toward other students and college professors.
- [REDACTED] suggested we speak to [REDACTED] about complaints others had brought against KOHBERGER. [REDACTED] is the [REDACTED]. (See supplement #91)
- I transferred the recorded interview to a compact disk (CD) and turned this disk over to the Moscow Police Department evidence technician.
- Note: I misquoted the date of the interview on the recording. I said "December 9th, 2023" when in fact it was January 9th, 2023".
