The interview took place at the [REDACTED] in Pullman, Washington. The interview was in reference to meeting Bryan C. KOHBERGER ([REDACTED] 1994) at a pool party in July 2022.

2. [REDACTED] was employed by [REDACTED] [REDACTED] [REDACTED] [REDACTED]. She was not associated with KOHBERGER at WSU.

3. She met KOHBERGER at a pool party on July 9, 2022. The pool party occurred at [REDACTED] located near the University of Idaho campus.

Narrative

4. When she met KOHBERGER, they had a brief conversation about hiking interests in the area. She told KOHBERGER she had a hiking group she could introduce him to, and the two exchanged phone numbers.
5. She could not recall if KOHBERGER was drinking at the pool party.
6. Nothing in particular stood out about KOHBERGER.
7. After the homicides, ██████████ searched her phone remembering KOHBERGER had sent her text. The text was as follows, "Hey, I am pretty sure we spoke about hiking trips yesterday. I really enjoy that activity, so please let me know! Thanks!"
8. ██████████ believed an individual named ██████████ ██████████ invited KOHBERGER to the pool party.
9. For further details, refer to the recording of the interview. A copy of the interview was turned over to the Moscow Police Department and entered into evidence.
